

HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 23, strike lines 6 through 11 and substitute
2 "general fund for that fiscal year; EXCEPT THAT, FOR THE 2023-24 STATE
3 FISCAL YEAR, THE AMOUNT RETAINED AS A RESERVE MUST BE FIFTEEN
4 PERCENT OF THE AMOUNT APPROPRIATED FOR EXPENDITURE FROM THE
5 GENERAL FUND FOR THAT FISCAL YEAR PLUS FIFTEEN PERCENT OF THE
6 AMOUNT OF THE GENERAL FUND APPROPRIATIONS REDUCED PURSUANT TO
7 SECTION 24-75-226 (4)(a)(I); AND FOR THE 2024-25 STATE FISCAL YEAR,
8 THE AMOUNT RETAINED AS A RESERVE MUST BE FIFTEEN PERCENT OF THE
9 AMOUNT APPROPRIATED FOR EXPENDITURE FROM THE GENERAL FUND PLUS
10 FIFTY-SIX MILLION FOUR HUNDRED NINETY-THREE THOUSAND FIVE
11 HUNDRED FORTY-THREE DOLLARS."

12 Page 23 after line 11, insert:

13 "SECTION 6. In Colorado Revised Statutes, 24-75-201.1, **amend**
14 **as added by House Bill 24-1231** (1)(d)(XXIII)(B) as follows:

15 **24-75-201.1. Restriction on state appropriations - legislative**
16 **declaration - definitions.** (1) (d) (XXIII) (B) For the fiscal year 2023-24
17 and each fiscal year thereafter until the escrow money is released as set
18 forth in section 23-40-107, ~~fifteen percent of the amount appropriated for~~
19 ~~expenditure from the general fund~~ THE AMOUNT OF THE RESERVE
20 DESCRIBED IN SUBSECTION (1)(d)(XXIII)(A) OF THIS SECTION for that
21 fiscal year reduced by forty-one million two hundred fifty thousand
22 dollars. As used in this subsection (1)(d)(XXIII)(B), "escrow money" has
23 the same meaning as set forth in section 23-40-107 (1)(c)."

24 Renumber succeeding sections accordingly.

25 Page 138, strike lines 1 and 2, and substitute:

26 "SECTION 86. **Effective date.** (1) Except as otherwise provided
27 in this section, this act takes effect upon passage.

28 (2) Sections 53 to 66 and 82 of this act take effect only if House".

29 Page 138, line 3, strike "52 to 65 and 81" and substitute "53 to 66 and
30 82".

31 Page 138, after line 3, insert:

32 "(3) Section 24-75-201.1 (1)(d)(XXIII)(B), Colorado Revised
33 Statutes, amended in section 6 of this act, takes effect only if House Bill
34 24-1231 becomes law."
