Committee on Health & Insurance.

HB20-1065 be amended as follows:

1 Amend printed bill, page 4, strike lines 12 through 27 and substitute:

2 **"SECTION 6.** In Colorado Revised Statutes, 25-1-520, **amend**
3 (2.5) as follows:

4 **25-1-520. Clean syringe exchange programs - operation -**
5 **approval - reporting requirements.** (2.5) (a) A ~~program developed~~
6 ~~pursuant to this section may be operated in a hospital~~ NONPROFIT
7 ORGANIZATION WITH EXPERIENCE OPERATING A CLEAN SYRINGE
8 EXCHANGE PROGRAM OR A HEALTH FACILITY licensed or certified by the
9 state ~~department pursuant to section 25-1.5-103 (1)(a)~~ MAY OPERATE A
10 CLEAN SYRINGE EXCHANGE PROGRAM WITHOUT PRIOR BOARD APPROVAL.

11 (b) A HEALTH FACILITY THAT OPERATES A CLEAN SYRINGE
12 EXCHANGE PROGRAM PURSUANT TO THIS SUBSECTION (2.5) SHALL REPORT
13 TO THE STATE DEPARTMENT EACH MONTH DETAILING THE DEMOGRAPHICS
14 OF THE CLIENTS THE FACILITY SERVED, THE NUMBER OF CLEAN SYRINGES
15 DISPENSED, AND THE NUMBER OF USED SYRINGES COLLECTED.

16 (c) PRIOR TO OPERATING A CLEAN SYRINGE EXCHANGE PROGRAM
17 PURSUANT TO THIS SUBSECTION (2.5), A NONPROFIT ORGANIZATION SHALL
18 CONSULT WITH INTERESTED STAKEHOLDERS AND DISCUSS THE ISSUES
19 DESCRIBED IN SUBSECTION (1) OF THIS SECTION. A NONPROFIT
20 ORGANIZATION THAT OPERATES A CLEAN SYRINGE EXCHANGE PROGRAM
21 PURSUANT TO THIS SUBSECTION (2.5) SHALL REPORT TO THE STATE
22 DEPARTMENT EACH MONTH DETAILING THE DEMOGRAPHICS OF THE
23 CLIENTS THE NONPROFIT ORGANIZATION SERVED, THE NUMBER OF CLEAN
24 SYRINGES DISPENSED, AND THE NUMBER OF USED SYRINGES COLLECTED.". .

25 Strike page 5.

26 Page 6, strike lines 1 through 14.

27 Rerumber succeeding sections accordingly.

28 Page 1, line 101, strike "MEASURES" and substitute "THE USE OF
29 MEASURES THAT DO NOT INVOLVE SCHEDULE 1 CONTROLLED
30 SUBSTANCES".
