HB24-1313 be amended as follows:

13 BEFORE JANUARY 1, 2030."

27 OR SIMILAR RECORDED AGREEMENT TO ENSURE AFFORDABILITY, OR HAS
28 BEEN INCOME-RESTRICTED UNDER A LOCAL INCLUSIONARY ZONING
29 ORDINANCE OR OTHER REGULATION OR PROGRAM;

30 (b) RESTRICTS OR LIMITS MAXIMUM RENTAL OR SALE PRICE FOR

22 SECTION, BASED ON ROUTES IDENTIFIED IN AN APPLICABLE TRANSIT PLAN
23 FOR EXISTING STATIONS FOR:
- 24 (a) COMMUTER BUS RAPID TRANSIT;
25 (b) COMMUTER RAIL; AND
26 (c) LIGHT RAIL.
- 27 (3) **Transit corridor area criteria.** (a) THE DEPARTMENT SHALL
28 DESIGNATE TRANSIT CORRIDOR AREAS, FOR PURPOSES OF SUBSECTION (1)
29 OF THIS SECTION, BY IDENTIFYING TRANSIT ROUTES THAT MEET THE
30 FOLLOWING CRITERIA:
- 31 (I) AN URBAN BUS RAPID TRANSIT SERVICE THAT IS IDENTIFIED
32 WITHIN:
- 33 (A) A METROPOLITAN PLANNING ORGANIZATION'S
34 FISCALLY-CONSTRAINED, LONG-RANGE TRANSPORTATION PLAN ADOPTED

1 PRIOR TO JANUARY 1, 2024, AND PLANNED FOR IMPLEMENTATION,
2 ACCORDING TO THAT PLAN, PRIOR TO JANUARY 1, 2030; OR
3 (B) AN APPLICABLE TRANSIT PLAN THAT HAS BEEN PLANNED FOR
4 SHORT-TERM IMPLEMENTATION, ACCORDING TO THAT PLAN;
5 (II) A PUBLIC BUS ROUTE THAT:
6 (A) HAS A PLANNED FREQUENCY OR SCHEDULED FREQUENCY OF
7 FIFTEEN MINUTES OR MORE FREQUENT DURING THE HIGHEST FREQUENCY
8 SERVICE HOURS; AND
9 (B) IS IDENTIFIED WITHIN AN APPLICABLE TRANSIT PLAN FOR
10 SHORT-TERM IMPLEMENTATION OR IMPLEMENTATION BEFORE JANUARY 1,
11 2030, ACCORDING TO THAT PLAN.
12 (b) FOR TRANSIT AGENCIES WITHIN METROPOLITAN PLANNING
13 ORGANIZATIONS THAT DO NOT HAVE APPLICABLE TRANSIT PLANS, THE
14 DEPARTMENT SHALL DESIGNATE TRANSIT CORRIDOR AREAS, FOR PURPOSES
15 OF SUBSECTION (1) OF THIS SECTION, BY IDENTIFYING ANY PUBLIC BUS
16 ROUTES WITH EXISTING TRANSIT SERVICE LEVELS AS OF JANUARY 1, 2024,
17 WITH A SCHEDULED FREQUENCY OF FIFTEEN MINUTES OR MORE FREQUENT
18 DURING THE HIGHEST FREQUENCY SERVICE HOURS.
19 (c) NOTWITHSTANDING SUBSECTION (3)(a) AND (3)(b) OF THIS
20 SECTION, THE DEPARTMENT SHALL NOT DESIGNATE TRANSIT CORRIDOR
21 AREAS, FOR PURPOSES OF SUBSECTION (1) OF THIS SECTION, WITHIN A
22 TRANSIT-ORIENTED COMMUNITY THAT HAS DESIGNATED TWENTY PERCENT
23 OR MORE OF ITS AREA AS A MANUFACTURED HOME ZONING DISTRICT AS OF
24 JANUARY 1, 2024.
25 (4) **Optional transit area criteria.** (a) THE DEPARTMENT SHALL
26 DESIGNATE OPTIONAL TRANSIT AREAS, FOR PURPOSES OF SUBSECTION (1)
27 OF THIS SECTION, BASED ON THE FOLLOWING CRITERIA:
28 (I) A BUS RAPID TRANSIT SERVICE THAT IS IDENTIFIED WITHIN A
29 METROPOLITAN PLANNING ORGANIZATION'S FISCALLY-CONSTRAINED,
30 LONG-RANGE TRANSPORTATION PLAN ADOPTED PRIOR TO JANUARY 1,
31 2024, AND INTENDED FOR IMPLEMENTATION AFTER JANUARY 1, 2030, AND
32 BEFORE DECEMBER 31, 2050;
33 (II) PUBLIC BUS ROUTES OTHER THAN THOSE IDENTIFIED IN
34 SUBSECTION (3)(a)(II)(B) OF THIS SECTION THAT OPERATE AT A
35 FREQUENCY OF THIRTY MINUTES OR MORE FREQUENT DURING THE HIGHEST
36 FREQUENCY SERVICE HOURS AS IDENTIFIED BY:
37 (A) EXISTING SERVICE AS OF JANUARY 1, 2024; OR
38 (B) IDENTIFIED WITHIN AN APPLICABLE TRANSIT PLAN; AND
39 (III) OTHER AREAS PLANNED AS A MIXED-USE PEDESTRIAN
40 ORIENTED NEIGHBORHOODS.
41 (b) FOR PURPOSES OF SUBSECTION (4)(a)(III) OF THIS SECTION, A
42 TRANSIT ORIENTED COMMUNITY MAY REQUEST THAT THE DEPARTMENT
43 DESIGNATE A MIXED-USE PEDESTRIAN-ORIENTED NEIGHBORHOOD AS AN

1 OPTIONAL TRANSIT AREA. THE DEPARTMENT SHALL REVIEW AND APPROVE
2 OR REJECT SUCH A REQUEST BASED ON WHETHER THE MIXED-USE
3 PEDESTRIAN-ORIENTED NEIGHBORHOOD FULFILLS THE GOALS OF THIS PART
4 2 ESTABLISHED IN SECTION 29-35-203 (2).

5 **(5) Potential transit area criteria.** (a) THE DEPARTMENT SHALL
6 DESIGNATE AN AREA AS A POTENTIAL TRANSIT AREA, FOR PURPOSES OF
7 SUBSECTION (1) OF THIS SECTION, IF IT CONSISTS OF CORRIDORS, AS
8 IDENTIFIED BY THE DEPARTMENT OF TRANSPORTATION THAT:

9 (I) INCLUDE MAJOR TRAVEL SHEDS, AS DEFINED BY COMMON
10 TRAVEL PATTERNS IN AN AREA, THAT IMPACT ANTICIPATED NEW OR
11 MODIFIED INTERCHANGES ON STATE-OWNED HIGHWAYS; AND

12 (II) ARE OUTSIDE OF CENSUS URBANIZED AREAS, AS IDENTIFIED IN
13 THE LATEST FEDERAL DECENNIAL CENSUS;

14 (b) IN DESIGNATING POTENTIAL TRANSIT AREAS, FOR PURPOSES OF
15 SUBSECTION (1) OF THIS SECTION, THE DEPARTMENT SHALL ATTEMPT TO
16 IDENTIFY AREAS WHERE FUTURE TRANSIT SERVICE AND NEIGHBORHOOD
17 CENTERS COULD POTENTIALLY ALIGN TO PROVIDE INFORMATION FOR
18 STATE, REGIONAL, AND LOCAL PLANNING EFFORTS.

19 (c) IN UPDATING THE TRANSIT AREA MAP PURSUANT TO
20 SUBSECTION (1) OF THIS SECTION, THE DEPARTMENT SHALL IDENTIFY ANY
21 NEIGHBORHOOD CENTERS THAT A LOCAL GOVERNMENT HAS DESIGNATED
22 WITHIN A POTENTIAL TRANSIT AREA."
