11 GOAL REPORT SUBMITTED PURSUANT TO SECTION 29-35-204 (8)(a);

12 (d) A TRANSIT-ORIENTED COMMUNITY'S PROGRESS REPORT
13 SUBMITTED PURSUANT TO SECTION 29-35-204 (9);

14 (e) A TRANSIT-ORIENTED COMMUNITY'S REQUEST TO DESIGNATE
15 AN AREA AS A TRANSIT CENTER PURSUANT TO SECTION 29-35-206 (2);

16 (f) CERTAIN AREAS AS TRANSIT AREAS PURSUANT TO SECTION
17 29-35-208; AND

18 (g) A TRANSIT-ORIENTED COMMUNITY'S LOCAL LAWS OR
19 PROGRAMS AS AN AFFORDABILITY STRATEGY FOR PURPOSES OF SECTION
20 29-35-204 (6)(a) AND (6)(b) PURSUANT TO SECTION 29-35-209 (3).

21 (2) IN FILING AN ACTION FOR JUDICIAL REVIEW PURSUANT TO
22 SUBSECTION (1) OF THIS SECTION, A TRANSIT-ORIENTED COMMUNITY MUST
23 FILE FOR JUDICIAL REVIEW IN THE DISTRICT COURT FOR THE CITY AND
24 COUNTY OF DENVER OR THE DISTRICT COURT IN THE COUNTY IN WHICH
25 THE TRANSIT-ORIENTED COMMUNITY IS LOCATED.

26 (3) THE PROCEDURE AND TIMELINES FOR FILING A COMPLAINT, AN
27 ANSWER, AND BRIEFS FOR JUDICIAL REVIEW PURSUANT TO THIS SECTION
28 SHALL BE IN ACCORDANCE WITH THE PROCEDURES SPECIFIED IN RULE 106
29 (a)(4) AND (b) OF THE COLORADO RULES OF CIVIL PROCEDURE."
