

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Hansen

1 Amend printed bill, page 7, strike lines 7 through 10 and substitute:

2           "(g) AN AMOUNT TO PROVIDE FOR THE PAYMENT OF BONDS THAT  
3 ARE OUTSTANDING AS OF THE EFFECTIVE DATE OF THIS PART 17 AND THE  
4 INTEREST THEREON, OR FOR THE PAYMENT OF ANY OTHER CONTRACTUAL  
5 OBLIGATION THAT HAS BEEN APPROVED BY A MAJORITY OF THE LOCAL  
6 GOVERNMENTAL ENTITY'S VOTERS VOTING THEREON OUTSTANDING AS OF  
7 THE EFFECTIVE DATE OF THIS PART 17; AND BONDS OR OTHER  
8 CONTRACTUAL OBLIGATIONS ISSUED IN ACCORDANCE WITH THE EXISTING  
9 VOTED AUTHORIZATION OF A LOCAL GOVERNMENTAL ENTITY APPROVED  
10 BY A MAJORITY OF THE LOCAL GOVERNMENTAL ENTITY'S VOTERS VOTING  
11 THEREON IN ACCORDANCE WITH ARTICLE X SECTION 20 OF THE STATE  
12 CONSTITUTION AS OF THE EFFECTIVE DATE OF THIS PART 17; AND"

13 Page 10, strike lines 5 through 14 and substitute "**mill increases.**  
14 (1) NOTHING IN THIS PART 17 IMPAIRS:

15           (a) THE OBLIGATIONS OF ANY BONDS OR OTHER FORMS OF  
16 INDEBTEDNESS THAT ARE OUTSTANDING AS OF THE EFFECTIVE DATE OF  
17 THIS PART 17, OR THE REFUNDING THEREOF, ISSUED BY A LOCAL  
18 GOVERNMENTAL ENTITY OR OTHERWISE INVALIDATES ANY SUCH BOND OR  
19 THE OBLIGATIONS OR REFUNDING THEREOF; OR

20           (b) THE EXISTING VOTED AUTHORIZATION OF A LOCAL  
21 GOVERNMENTAL ENTITY APPROVED BY A MAJORITY OF THE LOCAL  
22 GOVERNMENTAL ENTITY'S VOTERS VOTING THEREON IN ACCORDANCE  
23 WITH ARTICLE X SECTION 20 OF THE STATE CONSTITUTION AS OF THE  
24 EFFECTIVE DATE OF THIS PART 17. AS ESTABLISHED IN SECTION 29-1-1701  
25 (3)(g), THE IMPOSITION OF A LEVY TO PROVIDE FOR THE PAYMENT OF:

26           (I) BONDS THAT ARE OUTSTANDING AS OF THE EFFECTIVE DATE OF  
27 THIS PART 17 AND THE INTEREST THEREON, OR FOR THE PAYMENT OF ANY  
28 OTHER CONTRACTUAL OBLIGATION OUTSTANDING AS OF THE EFFECTIVE  
29 DATE OF THIS PART 17 THAT HAS BEEN APPROVED BY A MAJORITY OF THE  
30 LOCAL GOVERNMENTAL ENTITY'S VOTERS VOTING THEREON; AND

31           (II) BONDS OR OTHER CONTRACTUAL OBLIGATIONS ISSUED IN  
32 ACCORDANCE WITH THE EXISTING VOTED AUTHORIZATION OF A LOCAL  
33 GOVERNMENTAL ENTITY APPROVED BY A MAJORITY OF THE LOCAL  
34 GOVERNMENTAL ENTITY'S VOTERS VOTING THEREON IN ACCORDANCE  
35 WITH ARTICLE X SECTION 20 OF THE STATE CONSTITUTION AS OF THE  
36 EFFECTIVE DATE OF THIS PART 17 IS NOT INCLUDED IN THE CALCULATION  
37 OF THE PROPERTY TAX LIMIT."

38 Page 20, line 8, strike "THIS SENATE BILL 24-\_\_\_\_," and substitute  
39 "SENATE BILL 24-233,".
