PURPOSE: Increases the appropriation for Medical Services Premiums in the Department of **Health Care Policy and Financing** by \$7,592,095 total funds, including \$5,061,397 General Fund. Reduces the appropriation for Vehicle Replacement Lease/Purchase for the State Fleet Management and Motor Pool Services program in the Department of **Personnel** by \$5,061,397 reappropriated funds. Eliminates all General Fund appropriations in **multiple departments** for vehicle lease payments for a total of \$5,061,397. Adds a footnote to the Medical Services Premiums line stating that the additional funding is to increase provider rates for the Program for All-Inclusive Care for the Elderly (PACE).
