Committee on Education.

SB22-087 be amended as follows:

- 1 Amend printed bill, page 6, strike line 23 and substitute "PROGRAM
- 2 THROUGH WHICH".
- 3 Page 6, line 27, after "AUTHORITY" insert "THAT PARTICIPATE IN THE
- 4 NATIONAL SCHOOL LUNCH PROGRAM OR NATIONAL SCHOOL BREAKFAST
- 5 PROGRAM".
- 6 Page 7, line 1, after the period add "THE PROGRAM IS EFFECTIVE
- 7 BEGINNING IN THE FIRST FULL BUDGET YEAR AFTER THE STATE OF
- 8 COLORADO IS CERTIFIED TO PARTICIPATE IN THE DEMONSTRATION PROJECT
- 9 FOR DIRECT CERTIFICATION FOR CHILDREN RECEIVING MEDICAID BENEFITS
- 10 AS PROVIDED IN SUBSECTION (4) OF THIS SECTION AND BEGINS INCLUDING
- 11 MEDICAID DIRECT CERTIFICATION IN DETERMINING SCHOOL DISTRICTS'
- 12 IDENTIFIED STUDENT PERCENTAGES."
- 13 Page 12, line 14, strike "SEPTEMBER 1, 2024," and substitute "SEPTEMBER
- 14 1 OF THE SECOND BUDGET YEAR IN WHICH THE PROGRAM IS
- 15 IMPLEMENTED,".
- 16 Page 12, line 26, strike "**increase.**" and substitute "**increase or stipend.**".
- 17 Page 13, line 8, after "WAGES" insert "OR PROVIDE STIPENDS".
- 18 Page 13, line 13, after "WAGES" insert "OR PROVISION OF STIPENDS".
- 19 Page 15, lines 5 and 6, strike "DECEMBER 1, 2024," and substitute
- 20 "DECEMBER 1 OF THE SECOND BUDGET YEAR IN WHICH THE PROGRAM IS
- 21 IMPLEMENTED,".
- 22 Page 15, line 18, after "PAID" insert "OR THE AMOUNT OF STIPENDS
- 23 PROVIDED".
- 24 Page 16, line 11, after "WAGES" insert "OR PROVISION OF STIPENDS".
- 25 Page 16, strike lines 14 and 15 and substitute "22-82.9-207. THE AUDIT OF
- 26 THE TWO BUDGET YEARS IN EACH BIENNIAL CYCLE MUST BE COMPLETED
- 27 BY DECEMBER 1 OF THE FOLLOWING BUDGET YEAR. THE DEPARTMENT".
- 28 Page 16, strike lines 18 and 19 and substitute:
- 29 "**22-82.9-209. Program - funding.** BEGINNING WITH THE FIRST
- 30 BUDGET YEAR IN WHICH THE PROGRAM TAKES EFFECT AND FOR".

1 Page 17, line 1, after "WAGES" insert "OR PROVIDE STIPENDS".
