

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Finance.

HB25-1268 be amended as follows:

- 1   Amend the Energy and Environment Committee Report, dated March 20,  
2   2025, page 3, strike lines 12 through 14 and substitute "MONEY THROUGH  
3   THE PROGRAM, EITHER DIRECTLY OR BY ELECTING TO HAVE ITS  
4   UTILITY-DESIGNATED ADMINISTRATOR RECEIVE MONEY; THROUGH A LOAN  
5   FROM THE OFFICE; OR THROUGH PARTICIPATION IN A PROGRAM  
6   ADMINISTERED BY THE PROGRAM ADMINISTRATOR IN WHICH THE  
7   PROGRAM ADMINISTRATOR RECEIVES MONEY FROM THE OFFICE TO  
8   MANAGE A UTILITY ON-BILL PROGRAM FOR THE UTILITY.".
- 9   Page 4, strike lines 2 and 3 and substitute "PARTICIPATING UTILITY OR THE  
10   PROGRAM ADMINISTRATOR, MONEY PROVIDED TO THE UTILITY OR ITS  
11   UTILITY-DESIGNATED ADMINISTRATOR".
- 12   Page 4, line 17, strike "PARTICIPANTS." and substitute "PARTICIPANTS AND  
13   NONPARTICIPANTS.".
- 14   Page 4, strike lines 35 through 38 and substitute "RECOVER PROGRAM  
15   ADMINISTRATION COSTS; AND".
- 16   Renumber succeeding subparagraph accordingly.
- 17   Page 5, after line 10 insert:
  - 18       "(c) FOR CONTRACTS WITH A REGULATED UTILITY OR THE  
19       REGULATED UTILITY'S UTILITY-DESIGNATED ADMINISTRATOR, THE FINAL  
20       CONTRACT MUST CONFORM WITH ANY FINAL APPROVAL FROM THE  
21       COMMISSION.
  - 22       "(d) A PARTICIPATING UTILITY OR ITS UTILITY-DESIGNATED  
23       ADMINISTRATOR SHALL BE RESPONSIBLE FOR REPAYING THE AMOUNT OF  
24       FUNDING PROVIDED FROM THE ON-BILL CASH FUND TO THE UTILITY OR ITS  
25       UTILITY-DESIGNATED ADMINISTRATOR.".
- 26   Page 5, line 38, strike "MINIMIZE" and substitute "MANAGE".
- 27   Page 7, line 2, strike "POSSIBLE" and substitute "REASONABLE".
- 28   Page 7, line 20, strike "RATES POSSIBLE" and substitute "REASONABLE  
29   RATES".
