

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 26, line 9, strike "IF" and substitute "EXCEPT AS  
2 OTHERWISE PROVIDED IN SUBSECTION (7) OF THIS SECTION, IF".

3 Page 26, after line 22 insert:

4        "(7) IF THE REGISTERED ELECTORS OF A DISTRICT APPROVE THE  
5 LEVY AND COLLECTION OF AN AD VALOREM TAX PURSUANT TO THIS  
6 SECTION, BUT LESS THAN FORTY PERCENT OF THE REGISTERED ELECTORS  
7 OF A COUNTY IN THE DISTRICT WITH A POPULATION OF FIFTEEN THOUSAND  
8 PEOPLE OR FEWER APPROVE THE LEVY AND COLLECTION OF SUCH TAX, THE  
9 BOARD OF COUNTY COMMISSIONERS OF THE COUNTY MAY, WITHIN THIRTY  
10 DAYS OF THE CERTIFICATION OF THE ELECTION, VOTE TO BE EXCLUDED  
11 FROM THE BOUNDARIES OF THE DISTRICT. IF SUCH A BOARD OF COUNTY  
12 COMMISSIONERS DOES NOT VOTE TO BE EXCLUDED FROM THE BOUNDARIES  
13 OF THE DISTRICT, THE COUNTY WILL BE INCLUDED IN THE DISTRICT AND  
14 ALL OF THE APPLICABLE PROVISIONS OF THIS ARTICLE 23 SHALL APPLY TO  
15 THE COUNTY. IF SUCH A BOARD OF COUNTY COMMISSIONERS DOES VOTE  
16 TO BE EXCLUDED FROM THE BOUNDARIES OF THE DISTRICT, THE  
17 PROVISIONS OF THIS ARTICLE 23 SHALL NOT APPLY TO THE COUNTY AND  
18 THE AD VALOREM TAX AUTHORIZED BY THE DISTRICT WILL NOT BE LEVIED  
19 OR COLLECTED IN THE COUNTY.".

20 Page 32, line 9, strike "AND".

21 Page 32, line 10, strike "MANAGEMENT." and substitute "MANAGEMENT;  
22 AND

23        (e) HAVE ITS PRINCIPAL OFFICE WITHIN THE CREATED DISTRICT,  
24 CONDUCT THE MAJORITY OF ITS ACTIVITIES WITHIN THE STATE OF  
25 COLORADO, AND PRINCIPALLY OPERATE FOR THE BENEFIT OF THE  
26 RESIDENTS OF THE CREATED DISTRICT.".
