

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB20-1022 be amended as follows:

1 Amend reengrossed bill, page 2, line 3, strike "(3);" and substitute "(1)(a),
2 (3), and (5);".

3 Page 2, strike line 6 and substitute:

4 **"creation - definition.** (1) (a) (I) Notwithstanding section 2-3-303.3,
5 there is created the sales and use tax simplification task force, referred to
6 in this part 8 as the "task force". ~~which~~ THE TASK FORCE shall meet as
7 necessary during any legislative session or any interim between legislative
8 sessions to study the necessary components of a simplified sales and use
9 tax system for both the state and local governments, including home rule
10 municipalities and counties.

11 (II) (A) NOTWITHSTANDING SUBSECTION (1)(a)(I) OF THIS
12 SECTION, THE TASK FORCE SHALL NOT MEET DURING THE 2020 INTERIM.

13 (B) THIS SUBSECTION (1)(a)(II) IS REPEALED, EFFECTIVE JULY 1,
14 2021.

15 (b) (I) THE TASK FORCE SHALL STUDY SALES".

16 Page 5, line 25, after "(2.5)" insert "(a)".

17 Page 5, line 26, strike "JUNE 5, 2020, AND EACH JUNE 5" and substitute
18 "JUNE 1, 2021, AND EACH JUNE 1".

19 Page 6, after line 7 insert:

20 "(b) STARTING IN 2021, THE TASK FORCE SHALL ELECT A CHAIR
21 AND A VICE-CHAIR AT THE FIRST MEETING HELD ON OR BEFORE JULY 16,
22 2021. THE CHAIR AND VICE-CHAIR APPOINTMENTS MUST ALTERNATE
23 BETWEEN A MEMBER FROM THE HOUSE OF REPRESENTATIVES AND A
24 MEMBER FROM THE SENATE WITH THE FIRST CHAIR BEING FROM THE
25 SENATE AND THE FIRST VICE-CHAIR BEING FROM THE HOUSE OF
26 REPRESENTATIVES. THE PERSON SERVING AS CHAIR, OR A MEMBER OF THE
27 SAME HOUSE IF SUCH PERSON IS NO LONGER A MEMBER THEREOF, SHALL
28 SERVE AS VICE-CHAIR DURING THE NEXT LEGISLATIVE SESSION, AND THE
29 PERSON SERVING AS VICE-CHAIR, OR A MEMBER OF THE SAME HOUSE IF
30 SUCH PERSON IS NO LONGER A MEMBER THEREOF, SHALL SERVE AS CHAIR
31 DURING THE NEXT LEGISLATIVE SESSION."

32 Page 6, line 8, strike "The task" and substitute "STARTING IN 2021, the
33 task".

34 Page 6, line 9, strike "JULY 17, 2020." and substitute "JULY 16, 2021.".

- 1 Page 6, after line 11 insert:
2 "(5) No later than ~~November 1, 2017~~ NOVEMBER 1, 2021, and no
3 later than each November 1 thereafter, the task force shall make a report
4 to the legislative council created in section 2-3-301 that may or may not
5 include recommendations for legislation."
- 6 Page 6, line 16, strike "2025." and substitute "2026."
- 7 Page 6, strike lines 25 through 27 and substitute
8 "**SECTION 4.** In Colorado Revised Statutes, 2-3-1704, **add** (12)
9 as follows:
10 **2-3-1704. Powers and duties of the joint technology committee.**
11 (12) BETWEEN ADJOURNMENT SINE DIE OF THE SECOND REGULAR SESSION
12 OF THE SEVENTY-SECOND GENERAL ASSEMBLY AND THE FIRST MEETING IN
13 2021 OF THE SALES AND USE TAX SIMPLIFICATION TASK FORCE CREATED
14 IN SECTION 39-26-802, THE COMMITTEE SHALL:
15 (a) SEEK REGULAR UPDATES FROM THE OFFICE OF INFORMATION
16 TECHNOLOGY AND THE DEPARTMENT OF REVENUE REGARDING THE
17 DEVELOPMENT OF THE ELECTRONIC SALES AND USE TAX SIMPLIFICATION
18 SYSTEM DESCRIBED IN SENATE BILL 19-006, ENACTED IN 2019;
19 (b) ONCE THE ELECTRONIC SALES AND USE TAX SIMPLIFICATION
20 SYSTEM DESCRIBED IN SENATE BILL 19-006, ENACTED IN 2019, IS ONLINE,
21 MONITOR AND ENCOURAGE PARTICIPATION BY BUSINESSES AND HOME
22 RULE MUNICIPALITIES; AND
23 (c) SEEK REGULAR UPDATES FROM THE OFFICE OF INFORMATION
24 TECHNOLOGY AND THE DEPARTMENT OF REVENUE REGARDING THE
25 PURCHASE AND DEVELOPMENT OF A GEOGRAPHIC INFORMATION SYSTEM
26 (GIS) DATABASE TO MAINTAIN JURISDICTIONAL BOUNDARIES OF SALES
27 TAX DISTRICTS AND TO CALCULATE APPROPRIATE SALES AND USE TAX
28 RATES FOR INDIVIDUAL ADDRESSES FOR WHICH THE DEPARTMENT OF
29 REVENUE RECEIVED AN APPROPRIATION IN SENATE BILL 19-006, ENACTED
30 IN 2019."
- 31 Page 7, strike lines 1 through 7.
- 32 Page 1, line 103, after "**DUTIES,**" insert "**AND**".
- 33 Page 1, strike lines 106 and 107 and substitute "**PRIOR TO THE TASK**
34 **FORCE'S REPEAL.**".
