

1 Amend printed bill, page 2, strike lines 2 through 4 and substitute:

2           **"SECTION 1.** In Colorado Revised Statutes, 39-1-103, **add** (19)  
3 as follows:

4           **39-1-103. Actual value determined - when - legislative**  
5 **declaration - definitions.** (19) (a) AS USED IN THIS SUBSECTION (19),  
6 UNLESS THE CONTEXT OTHERWISE REQUIRES:

7           (I) "PROPERTY" MEANS REAL PROPERTY, AS DEFINED IN SECTION  
8 39-1-102 (14), EXCLUSIVE OF PRODUCING MINES AND NONPRODUCING  
9 MINING CLAIMS, LEASEHOLDS AND LANDS PRODUCING OIL OR GAS, THE  
10 OPERATING PROPERTY AND PLANTS OF ALL PUBLIC UTILITIES DOING  
11 BUSINESS IN THE STATE, AND MOBILE HOMES.

12           (II) "UNUSUAL CONDITION" MEANS AN ON-SITE IMPROVEMENT,  
13 THE ENDING OF THE ECONOMIC LIFE OF AN IMPROVEMENT WITH ONLY  
14 SALVAGE VALUE REMAINING, THE ADDITION TO OR REMODELING OF A  
15 STRUCTURE, A CHANGE OF USE OF LAND, THE CREATION OF A  
16 CONDOMINIUM OWNERSHIP OF REAL PROPERTY AS RECOGNIZED IN THE  
17 "CONDOMINIUM OWNERSHIP ACT", ARTICLE 33 OF TITLE 38, A NEW  
18 REGULATION RESTRICTING OR INCREASING THE USE OF THE LAND, THE  
19 INSTALLATION AND OPERATION OF SURFACE EQUIPMENT RELATING TO OIL  
20 AND GAS WELLS ON AGRICULTURAL LAND, A DETRIMENTAL ACT OF  
21 NATURE, AND DAMAGE DUE TO ACCIDENT, VANDALISM, FIRE, OR  
22 EXPLOSION. THE CREATION OF A CONDOMINIUM OWNERSHIP OF REAL  
23 PROPERTY BY THE CONVERSION OF AN EXISTING STRUCTURE IS  
24 CONSIDERED AN UNUSUAL CONDITION FOR PURPOSES OF THIS SUBSECTION  
25 (19) WHEN AT LEAST FIFTY-ONE PERCENT OF THE CONDOMINIUM UNITS, AS  
26 DEFINED IN SECTION 38-33-103(1), IN A MULTIUNIT PROPERTY SUBJECT TO  
27 CONDOMINIUM OWNERSHIP HAVE BEEN SOLD AND CONVEYED TO BONA  
28 FIDE PURCHASERS AND DEEDS HAVE BEEN RECORDED FOR THOSE UNITS.

29           (b) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION,  
30 FOR THE 2023 PROPERTY TAX YEAR, THE ACTUAL VALUE OF A PROPERTY  
31 SHALL NOT EXCEED ONE HUNDRED SIX PERCENT OF THE ACTUAL VALUE,  
32 AS DETERMINED IN ACCORDANCE WITH SECTION 3 OF ARTICLE X OF THE  
33 STATE CONSTITUTION, OF THE SAME PROPERTY FOR THE 2022 PROPERTY  
34 TAX YEAR.

35           (c) SUBSECTION (19)(b) OF THIS SECTION DOES NOT APPLY TO A  
36 PROPERTY THAT HAS AN UNUSUAL CONDITION THAT RESULTS IN AN  
37 INCREASE IN ACTUAL VALUE.".
