

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Finance.

SB20-217 be amended as follows:

- 1 Amend reengrossed bill, page 7, lines 7 and 8, strike "DECEDENT'S FAMILY  
2 AT LEAST TWENTY-FOUR HOURS PRIOR TO PUBLIC DISCLOSURE." and  
3 substitute "VICTIM OR, IF THE VICTIM IS DECEASED OR INCAPACITATED,  
4 THEY MUST BE RELEASED TO THE VICTIM'S SPOUSE, PARENT, LEGAL  
5 GUARDIAN, CHILD, SIBLING, GRANDPARENT, GRANDCHILD, SIGNIFICANT  
6 OTHER, OR OTHER LAWFUL REPRESENTATIVE, AND SUCH PERSON SHALL BE  
7 NOTIFIED OF HIS OR HER RIGHT, PURSUANT TO SECTION 24-4.1-302.5  
8 (1)(j.8), TO RECEIVE AND REVIEW THE RECORDING AT LEAST SEVENTY-TWO  
9 HOURS PRIOR TO PUBLIC DISCLOSURE. A PERSON EIGHTEEN YEARS OF AGE  
10 AND UNDER IS CONSIDERED INCAPACITATED, UNLESS LEGALLY  
11 EMANCIPATED.".
- 12 Page 7, line 16, strike "OR LICENSE PLATE".
- 13 Page 7, line 23, after the period add "UNREDACTED FOOTAGE MUST NOT  
14 BE RELEASED WITHOUT THE WRITTEN AUTHORIZATION OF THE VICTIM OR,  
15 IF THE VICTIM IS DECEASED OR INCAPACITATED, THE WRITTEN  
16 AUTHORIZATION OF THE VICTIM'S SPOUSE, PARENT, LEGAL GUARDIAN,  
17 CHILD, SIBLING, GRANDPARENT, GRANDCHILD, SIGNIFICANT OTHER, OR  
18 OTHER LAWFUL REPRESENTATIVE. A PERSON EIGHTEEN YEARS OF AGE AND  
19 UNDER IS CONSIDERED INCAPACITATED, UNLESS LEGALLY EMANCIPATED.  
20 IN THE EVENT THE VICTIM OR THE VICTIM'S SPOUSE, PARENT, LEGAL  
21 GUARDIAN, CHILD, SIBLING, GRANDPARENT, GRANDCHILD, SIGNIFICANT  
22 OTHER, OR OTHER LAWFUL REPRESENTATIVE CANNOT BE NOTIFIED OF HIS  
23 OR HER RIGHT TO REVIEW THE RECORDINGS, DECLINES TO REVIEW THE  
24 RECORDINGS, OR DECLINES TO PROVIDE AUTHORIZATION FOR THEIR  
25 RELEASE, IT IS PRESUMED THAT NO AUTHORIZATION IS PROVIDED AND THE  
26 UNREDACTED RECORDING MUST NOT BE RELEASED TO THE PUBLIC.".
- 27 Page 7, strike line 27 and substitute "VICTIM OR, IF THE VICTIM IS  
28 DECEASED OR INCAPACITATED, TO THE VICTIM'S SPOUSE, PARENT, LEGAL  
29 GUARDIAN, CHILD, SIBLING, GRANDPARENT, GRANDCHILD, SIGNIFICANT  
30 OTHER, OR OTHER LAWFUL REPRESENTATIVE WITHIN".
- 31 Page 8, line 7, after the period add "THE HEARING SHALL BE CONSIDERED  
32 A CRITICAL STAGE PURSUANT TO SECTION 24-4.1-302 AND GIVES VICTIMS  
33 THE RIGHT TO BE HEARD PURSUANT TO 24-4.1-302.5.".
