HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB20-1085 be amended as follows:

- 1 Amend the Health and Insurance Committee Report, dated February 19,
2 2020, page 1, line 6, strike "THE CARRIER'S LOWEST COST-SHARING TIER,"
3 and substitute "A COST-SHARING AMOUNT NOT TO EXCEED THE
4 COST-SHARING AMOUNT FOR A PRIMARY CARE VISIT FOR NONPREVENTIVE
5 SERVICES,".
- 6 Page 1 of the report, after line 14 insert:
7 "Page 5 of the printed bill, line 25, strike "THE" and substitute "MORE
8 THAN ONE".".
- 9 Page 2 of the report, strike lines 1 through 3 and substitute "ATYPICAL
10 OPIOID" MEANS A NONOPIOID ANALGESIC WITH FAR LOWER FATALITY
11 RATES THAN PURE OPIOID AGONISTS.". ".
- 12 Page 4 of the report, after line 29 insert:
13 "Page 10 of the bill, line 14, strike "(3)(m), (4)(a.5)," and substitute
14 "(4)(a.5)".
- 15 Page 11 of the bill, strike lines 16 through 24."
- 16 Page 5 of the report, strike lines 3 through 7 and substitute:
17 "Page 12 of the bill, strike line 27 and substitute:
18 "(b) THE BOARD MAY, WITHIN EXISTING FUNDS AVAILABLE FOR
19 OPERATION OF THE PROGRAM, PROVIDE A MEANS OF".
- 20 Page 13 of the bill, strike lines 26 and 27.
- 21 Strike page 14 of the bill.
- 22 Page 15 of the bill, strike lines 1 through 15.
- 23 Renumber succeeding sections accordingly.
- 24 Page 15 of the bill, line 20, strike "(I)".
- 25 Page 16 of the bill, strike lines 4 through 8.

1 Page 16 of the bill, strike lines 9 through 27.

2 Strike pages 17 and 18 of the bill and substitute:

3 **"SECTION 20. Act subject to petition - effective date.** This act
4 takes effect at 12:01 a.m. on the day following the expiration of the
5 ninety-day period after final adjournment of the general assembly; except
6 that, if a referendum petition is filed pursuant to section 1 (3) of article V
7 of the state constitution against this act or an item, section, or part of this
8 act within such period, then the act, item, section, or part will not take
9 effect unless approved by the people at the general election to be held in
10 November 2022 and, in such case, will take effect on the date of the
11 official declaration of the vote thereon by the governor."."
