

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Transportation & Local Government Committee Report dated  
2 March 22, 2022, page 2, after line 11 insert:

3       (e) "REMOTE LOCATION" MEANS A LOCATION OF THE LESSOR'S  
4 BUSINESS THAT IS MORE THAN A TWO HOUR DRIVE FROM THE DENVER  
5 INTERNATIONAL AIRPORT."

6 Page 2, strike lines 17 through 26 and substitute:

7       ""(5) (a) A LESSOR MUST FULFILL A RESERVATION MADE BY A  
8 LESSEE FOR THE PROVISION OF A MOTOR VEHICLE WITH ADAPTIVE  
9 EQUIPMENT WITHIN FORTY-EIGHT HOURS OF THE LESSOR RECEIVING THE  
10 RESERVATION, UNLESS THE LESSEE REQUESTS THAT THE LESSOR PROVIDE  
11 THE MOTOR VEHICLE AT THE LESSOR'S BUSINESS LOCATION AT THE  
12 DENVER INTERNATIONAL AIRPORT OR AT A REMOTE LOCATION OF THE  
13 LESSOR'S BUSINESS.

14       (b) A LESSOR MUST FULFILL A RESERVATION MADE BY A LESSEE  
15 FOR THE PROVISION OF A MOTOR VEHICLE WITH ADAPTIVE EQUIPMENT AT  
16 THE LESSOR'S BUSINESS LOCATION AT THE DENVER INTERNATIONAL  
17 AIRPORT WITHIN EIGHT WORKING HOURS AFTER THE LESSOR RECEIVES THE  
18 RESERVATION AND AN EMPLOYEE TRAINED IN THE INSTALLATION OF  
19 ADAPTIVE EQUIPMENT IS ON DUTY AT THE LESSOR'S BUSINESS LOCATION  
20 AT THE DENVER INTERNATIONAL AIRPORT.

21       (c) A LESSOR MUST FULFILL A RESERVATION BY A LESSEE FOR THE  
22 PROVISION OF A MOTOR VEHICLE WITH ADAPTIVE EQUIPMENT AT A REMOTE  
23 LOCATION OF THE LESSOR'S BUSINESS WITHIN SEVENTY-TWO HOURS OF THE  
24 LESSOR RECEIVING THE RESERVATION.

25       (d) THE REQUIREMENTS OF THIS SUBSECTION (5) DO NOT APPLY IN  
26 THE CASE OF AN OCCURRENCE OF AN EVENT BEYOND THE LESSOR'S  
27 REASONABLE CONTROL, INCLUDING SEVERE WEATHER, ACTS OF GOD, ACTS  
28 OF TERRORISM."".
