19 ADMINISTRATIVE REVIEW DIVISION".
- 20 Page 2 of the report, line 12, strike "INDIVIDUAL," and substitute  
21 "INDIVIDUAL AND THE MOST RECENT ASSESSMENT,".
- 22 Page 2 of the report, line 21, after "COURT" insert "COURT OR  
23 ADMINISTRATIVE REVIEW DIVISION".
- 24 Page 7 of the bill, strike lines 15 through 27.
- 25 Strike page 8 of the bill.
- 26 Page 9 of the bill, strike lines 1 through 22.

- 2      Page 10 of the bill, strike lines 2 through 4 and substitute:  
3                 "(III) TO ASSIST IN THE EVALUATION OF THE IMPACT OF  
4                 COLORADO'S IMPLEMENTATION OF THE FEDERAL "FAMILY FIRST  
5                 PREVENTION SERVICES ACT" ON THE STATE'S JUVENILE JUSTICE SYSTEM  
6                 AND MAKE A FINDING OF WHETHER THE LACK OF AVAILABLE AND  
7                 APPROPRIATE CONGREGATE CARE PLACEMENTS IS A CONTRIBUTING  
8                 FACTOR IN COMMITTING A JUVENILE TO THE DIVISION OF YOUTH  
9                 SERVICES.".

11     15,".
- 12     Page 3 of the report, line 23, strike "SEPTEMBER 1, 2020." and substitute  
13     "JANUARY 15, 2021.".
- 14     Page 4 of the report, line 17, strike "PLAN. THE STATE" and substitute  
15     "PLAN OR ANY WAIVER IN".
- 16     Page 4 of the report, strike line 18.
- 17     Page 4 of the report, line 19, strike "SECTION" and substitute "SEC.".
- 18     Page 4 of the report, strike line 21.
- 19     Page 17 of the bill, strike line 22 and substitute "ORDER OR VOLUNTARY  
20     PLACEMENT; OR".
