

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB23-295 be amended as follows:

- 1 Amend printed bill, page 3, after line 21 insert:
  - 2 "(h) "SUB-TASK FORCE" MEANS THE SUB-TASK FORCE ESTABLISHED
  - 3 PURSUANT TO SUBSECTION (5)(a) OF THIS SECTION."
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 8, after line 15 insert:
  - 6 "(5) (a) THE TASK FORCE SHALL ESTABLISH A SUB-TASK FORCE TO
  - 7 STUDY TRIBAL MATTERS. THE SUB-TASK FORCE CONSISTS OF:
  - 8 (I) THE REPRESENTATIVE OF THE SOUTHERN UTE INDIAN TRIBE
  - 9 APPOINTED PURSUANT TO SUBSECTION (2)(a)(IV) OF THIS SECTION;
  - 10 (II) THE REPRESENTATIVE OF THE UTE MOUNTAIN UTE TRIBE
  - 11 APPOINTED PURSUANT TO SUBSECTION (2)(a)(V) OF THIS SECTION;
  - 12 (III) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OR THE
  - 13 DIRECTOR'S DESIGNEE; AND
  - 14 (IV) TWO OTHER MEMBERS JOINTLY APPOINTED BY THE SOUTHERN
  - 15 UTE INDIAN TRIBE, THE UTE MOUNTAIN UTE TRIBE, AND THE
  - 16 DEPARTMENT.
  - 17 (b) THE PURPOSE OF THE SUB-TASK FORCE IS TO PROVIDE
  - 18 RECOMMENDATIONS FOR STATE LEGISLATION THAT WILL:
  - 19 (I) PROVIDE FOR FULL TRIBAL PARTICIPATION IN THE PROGRAMS IN
  - 20 A MANNER THAT RECOGNIZES THE UNIQUE NATURE OF TRIBAL WATER
  - 21 RIGHTS AND TRIBAL WATER USE, SPECIFICALLY IN REGARD TO
  - 22 FORBEARANCE AND DEMAND MANAGEMENT OPPORTUNITIES;
  - 23 (II) PROVIDE FOR TRIBAL PARTICIPATION IN THE PROGRAMS IN A
  - 24 MANNER THAT IS VOLUNTARY, TEMPORARY, AND COMPENSATED; AND
  - 25 (III) EVALUATE SOURCES OF REVENUE TO APPROPRIATELY
  - 26 COMPENSATE THE SOUTHERN UTE INDIAN TRIBE AND THE UTE MOUNTAIN
  - 27 UTE TRIBE FOR PARTICIPATION IN THE PROGRAMS."
- 28 Renumber succeeding subsections accordingly.
- 29 Page 8, strike line 19 and substitute "FORCE, EXCEPT FOR PROPRIETARY
- 30 INFORMATION A STATE AGENCY HAS RECEIVED FROM THE SOUTHERN UTE
- 31 INDIAN TRIBE AND THE UTE MOUNTAIN UTE TRIBE."
- 32 Page 8, line 21, strike "(6)(b)" and substitute "(7)(b)".
- 33 Page 8, strike line 27 and substitute "SUBSECTIONS (4)(a) AND (5)(b) OF
- 34 THIS SECTION;"
- 35 Page 9, line 1, after "FORCE'S" insert "AND SUB-TASK FORCE'S".
- 36 After "FORCE" insert "AND SUB-TASK FORCE" on **Page 8**, lines 24 and 26;
- 37 and **Page 9**, lines 3 and 5.
