SB25-143 be amended as follows:

- 1 Amend printed bill, page 2, line 18, strike "EXIGENT".
- 2 Page 2, line 20, strike "FACE IS KNOWN" and insert "FACIAL IMAGING HAS
- 3 BEEN OBTAINED".
- 4 Page 3, lines 8 and 9, strike "AND THERE IS REASONABLE BELIEF THAT THE
- 5 STUDENT IS STILL ON" and substitute "BASED ON DATA THAT COULD
- 6 INDICATE THE STUDENT'S PRESENCE, LOCATION, OR MOVEMENTS WITHIN
- 7 OR AROUND".
- 8 Page 3, line 10, after "COURT" insert "OR BY THE SCHOOL
- 9 ADMINISTRATION".
- 10 Page 4, line 20, after "IDENTIFY" insert "AND LOCATE".
- 11 Page 4, line 21, strike "IN THE EXEMPTED CIRCUMSTANCE." and substitute
- 12 "FOR THE EXEMPTED CIRCUMSTANCE AND TO IDENTIFY AND LOCATE A
- 13 SPECIFIC INDIVIDUAL OR INDIVIDUALS WHOM THERE IS REASONABLE
- 14 SUSPICION TO BELIEVE WERE CONNECTED TO THE EXEMPTED
- 15 CIRCUMSTANCE".
- 16 Page 4, line 24, strike "TURNED ON," and substitute "ENABLED,".
- 17 Page 4, line 26, strike "TURNED OFF" and substitute "DISABLED" and after
- 18 "IDENTIFICATION" insert "AND DETERMINING THE LOCATION".
- 19 Page 4, line 27, after "INDIVIDUAL" insert "OR INDIVIDUALS".
- 20 Page 4, after line 27 insert:
- 21 "(IV) IN CIRCUMSTANCES DESCRIBED IN SUBSECTION (2)(d)(II) OF
- 22 THIS SECTION, IF THE STUDENT HAS BEEN DETERMINED TO NO LONGER BE
- 23 ON THE SCHOOL GROUNDS, THE FACIAL RECOGNITION SERVICES MUST BE
- 24 DISABLED ONCE THE LOCATION OF THE STUDENT WHO EXITED THE SCHOOL
- 25 GROUNDS HAS BEEN DETERMINED OR THE LAST KNOWN LOCATION OF THE
- 26 STUDENT ON SCHOOL GROUNDS HAS BEEN DETERMINED".
- 27 Page 5, line 20, strike "EXIGENT".
- 28 Page 5, line 22, strike "FACE IS KNOWN" and insert "FACIAL IMAGING HAS
- 29 BEEN OBTAINED".

- 1 Page 6, lines 3 and 4, strike "AND THERE IS REASONABLE BELIEF THAT THE
2 STUDENT IS STILL ON" and substitute "BASED ON DATA THAT COULD
3 INDICATE THE STUDENT'S PRESENCE, LOCATION, OR MOVEMENTS WITHIN
4 OR AROUND".
- 5 Page 6, line 5, after "COURT" insert "OR BY THE SCHOOL
6 ADMINISTRATION".
- 7 Page 7, line 15, after "IDENTIFY" insert "AND LOCATE".
- 8 Page 7, line 16, strike "IN THE EXEMPTED CIRCUMSTANCE." and substitute
9 "FOR THE EXEMPTED CIRCUMSTANCE AND TO IDENTIFY AND LOCATE A
10 SPECIFIC INDIVIDUAL OR INDIVIDUALS WHOM THERE IS REASONABLE
11 SUSPICION TO BELIEVE WERE CONNECTED TO THE EXEMPTED
12 CIRCUMSTANCE.".
- 13 Page 7, line 19, strike "TURNED ON," and substitute "ENABLED,".
- 14 Page 7, line 21, strike "TURNED OFF" and substitute "DISABLED" and after
15 "IDENTIFICATION" insert "AND DETERMINING THE LOCATION".
- 16 Page 7, line 22, after "INDIVIDUAL" insert "OR INDIVIDUALS".
- 17 Page 7, after line 22 insert:
18 "(IV) IN THE CIRCUMSTANCES DESCRIBED IN SUBSECTION (2)(d)(II)
19 OF THIS SECTION, IF THE STUDENT HAS BEEN DETERMINED TO NO LONGER
20 BE ON THE SCHOOL GROUNDS, THE FACIAL RECOGNITION SERVICES MUST
21 BE DISABLED ONCE THE LOCATION OF THE STUDENT WHO EXITED THE
22 SCHOOL GROUNDS HAS BEEN DETERMINED OR THE LAST KNOWN LOCATION
23 OF THE STUDENT ON SCHOOL GROUNDS HAS BEEN DETERMINED.".
