

## HOUSE FLOOR AMENDMENT

Second Reading BY REPRESENTATIVES McCormick and Catlin

1 Amend the Agriculture, Livestock, and Water Committee Report, dated  
2 March 7, 2022, page 1, strike line 1 and substitute:

3 "Amend printed bill, page 6, line 7, after "**add**" insert "(1.5)".

4 Page 6 of the bill, after line 9, insert:

5 "(1.5) "ANIMAL SHELTER" HAS THE MEANING SET FORTH IN  
6 SECTION 35-80-102."

7 Page 6 of the bill, strike line 23 and substitute "OR".

8 Page 1 of the committee report, after line 6 insert:

9 "Page 7 of the bill, line 22, after "TO" insert "ANIMAL".".

10 Page 1 of the committee report, after line 12 insert:

11 "Page 13 of the bill, strike lines 5 through 7 and substitute:

12 **"SECTION 16.** In Colorado Revised Statutes, **amend** 12-315-115  
13 as follows:

14 **12-315-115. Abandonment of animals - definition.** (1) An  
15 animal placed in the custody of a licensed veterinarian for treatment,  
16 boarding, or other care that is unclaimed by its owner or the owner's agent  
17 for more than ten days after written notice, by certified mail, return  
18 receipt requested, is given to the addressee at the last-known address is  
19 deemed to be abandoned and may be turned over to the nearest ~~humane~~  
20 ~~society~~ or animal shelter or disposed of in a manner deemed appropriate  
21 by the custodian.

22 (2) The".".

23 Page 2 of the committee report, strike lines 17 through 36.

24 Page 3 of the committee report, strike lines 1 and 2 and substitute:

25 **""SECTION 22.** In Colorado Revised Statutes, 12-280-103, **add**  
26 (2.5) as follows:

27 **12-280-103. Definitions - rules.** As used in this article 280, unless  
28 the context otherwise requires or the term is otherwise defined in another  
29 part of this article 280:

1 (2.5) "ANIMAL SHELTER" HAS THE MEANING SET FORTH IN SECTION  
2 35-80-102.

3                   **SECTION 23.** In Colorado Revised Statutes, 12-280-112, amend  
4 (1)(q) as follows:

**12-280-112. Fees.** (1) The director shall determine, and the board shall collect, fees pursuant to section 12-20-105 for the following licenses, certifications, and registrations:

8 (q) For the initial and renewal registration of ~~humane societies~~  
9 ANIMAL SHELTERS and animal control agencies pursuant to section  
10 12-280-119 (12);

11           **SECTION 24.** In Colorado Revised Statutes, 12-280-119, **amend**  
12       (12)(a) and (12)(b) as follows:

13                   **12-280-119. Registration of facilities - rules.** (12) (a) ~~A humane~~  
14 society AN ANIMAL SHELTER that is duly registered with the secretary of  
15 state and has been in existence and in business for at least five years in  
16 this state as a nonprofit corporation, or an animal control agency that is  
17 operated by a unit of government, shall register with the board.

(b) The board may issue a limited license to a humane society AN ANIMAL SHELTER or animal control agency to perform the activities described in section 12-280-120 (17).

**SECTION 25.** In Colorado Revised Statutes, 12-280-120, **amend** (17)(a) introductory portion and (17)(b); and **add** (17)(a)(III) as follows:

23                   **12-280-120. Compounding - dispensing - sale of drugs and**  
24                   **devices - rules - definition.** (17) (a) ~~A humane society, AN ANIMAL~~  
25                   SHELTER or animal control agency that is registered with the board  
26                   pursuant to section 12-280-119 (12) is authorized to:

27 (III) PURCHASE AND POSSESS VACCINES AND ADMINISTER  
28 VACCINES IN ACCORDANCE WITH APPLICABLE LAWS.

29 (b) ~~A society~~ AN ANIMAL SHELTER or ANIMAL CONTROL agency  
30 registered pursuant to section 12-280-119 (12) shall not permit a person  
31 to administer scheduled controlled substances, sodium pentobarbital, or  
32 sodium pentobarbital in combination with other noncontrolled  
33 prescription drugs that are medically recognized for euthanasia unless the  
34 person has demonstrated adequate knowledge of the potential hazards and  
35 proper techniques to be used in administering the drug or combination of  
36 drugs.

37                   **SECTION 26.** In Colorado Revised Statutes, 18-13-123, **amend**  
38                   (4)(b) as follows:

39                   **18-13-123. Unlawful administration of gamma**  
40 **hydroxybutyrate (GHB) or ketamine.** (4) (b) It shall not be IS NOT a  
41 violation of this section if ketamine is distributed or dispensed by or  
42 under the direction of ~~such authorized~~ A person AUTHORIZED AS  
43 DESCRIBED IN SUBSECTION (4)(a) OF THIS SECTION for use by ~~a humane~~

1       society ANIMAL SHELTER, AS DEFINED IN SECTION 35-80-102, that is  
2       duly registered with the secretary of state and has been in existence and  
3       in business for at least five years in this state as a nonprofit corporation  
4       or by an animal control agency that is operated by a unit of government  
5       to control animals and to euthanize injured, sick, homeless, or unwanted  
6       pets or animals if the ~~humane society~~ ANIMAL SHELTER or animal control  
7       agency is registered pursuant to section 12-280-119 (12).

8       **SECTION 27.** In Colorado Revised Statutes, **amend** 18-18-103  
9       as follows:

10      **18-18-103. Special definition - board.** As used in parts 1 and 2  
11      of this ~~article~~ ARTICLE 18, "board" means the state board of pharmacy. As  
12      used in parts 3, 4, 5, and 6 of this ~~article~~ ARTICLE 18, "board" means the  
13      respective licensing board responsible for licensing and registering  
14      practitioners or other persons who are subject to registration pursuant to  
15      part 3 of this ~~article~~ ARTICLE 18. For physicians the respective board is the  
16      Colorado medical board; for podiatrists the respective board is the  
17      Colorado podiatry board; for dentists the respective board is the Colorado  
18      dental board; for optometrists the respective board is the state board of  
19      optometry; for pharmacists and pharmacies the respective board is the  
20      state board of pharmacy; for veterinarians the respective board is the state  
21      board of veterinary medicine; and for manufacturers, distributors, and  
22      ~~humane societies~~ ANIMAL SHELTERS, AS DEFINED IN SECTION 35-80-102,  
23      the respective board is the state board of pharmacy.

24       **SECTION 28.** In Colorado Revised Statutes, 18-18-302, **amend**  
25       (1) as follows:

26      **18-18-302. Registration requirements - definitions.** (1) Every  
27      person who manufactures, distributes, or dispenses any controlled  
28      substance within this state, or who proposes to engage in the manufacture,  
29      distribution, or dispensing of any controlled substance within this state,  
30      shall obtain annually or biannually, if applicable, a registration, issued by  
31      the respective licensing board or the department in accordance with rules  
32      adopted by such board or by the department. For purposes of this section  
33      and this article 18, "registration" or "registered" means the registering of  
34      manufacturers, pharmacists, pharmacies, and ~~humane societies~~ ANIMAL  
35      SHELTERS, AS DEFINED IN SECTION 35-80-102, located in this state, and  
36      distributors located in or doing business in this state, by the state board of  
37      pharmacy, as set forth in article 280 of title 12, the licensing of physicians  
38      by the Colorado medical board, as set forth in article 240 of title 12, the  
39      licensing of podiatrists by the Colorado podiatry board, as set forth in  
40      article 290 of title 12, the licensing of dentists by the Colorado dental  
41      board, as set forth in article 220 of title 12, the licensing of optometrists  
42      by the state board of optometry, as set forth in article 275 of title 12, the  
43      licensing of veterinarians by the state board of veterinary medicine, as set

1 forth in article 315 of title 12, and the licensing of researchers and  
2 addiction programs by the department of human services, as set forth in  
3 part 2 of article 80 of title 27."".
