5 psychotherapists INDIVIDUALS LICENSED, CERTIFIED, OR REGISTERED  
6 PURSUANT TO THIS ARTICLE 245, except as provided in section".

7 Page 10, lines 24 and 25, strike "245 OR FOR WHICH THE PERSON HAS  
8 OBTAINED THE REQUIRED CREDENTIALS." and substitute "245.".

12       **"SECTION 14.** In Colorado Revised Statutes, **add** 12-245-222.5

14       **12-245-222.5. Mental health disciplinary record work group**  
15 **- creation - recommendations - report - repeal.** (1) THERE IS CREATED  
16 IN THE DIVISION THE MENTAL HEALTH DISCIPLINARY RECORD WORK GROUP  
17 CONCERNING RECORDS THAT IMPACT THE INITIAL LICENSURE,  
18 CERTIFICATION, REGISTRATION, AND ONGOING PRACTICE OF INDIVIDUALS  
19 REGULATED PURSUANT TO THIS ARTICLE 245.

20       (2) THE DIRECTOR SHALL SERVE AS A MEMBER OF THE WORK  
21 GROUP AND SHALL APPOINT ADDITIONAL MEMBERS THAT INCLUDE THE  
22 FOLLOWING:

23       (a) THREE MENTAL HEALTH PROFESSIONALS REGULATED  
24 PURSUANT TO THIS ARTICLE 245;

25       (b) TWO REPRESENTATIVES OF ASSOCIATIONS THAT REPRESENT  
26 PROFESSIONALS REGULATED UNDER THIS ARTICLE 245;

27       (c) ONE REPRESENTATIVE FROM THE OPIOID AND OTHER  
28 SUBSTANCE USE DISORDERS STUDY COMMITTEE CREATED IN SECTION  
29 10-22.3-101; AND

30       (d) THREE MEMBERS OF THE PUBLIC WHO OFFER EXPERTISE ON  
31 CRIMINAL JUSTICE REFORM, THE MENTAL HEALTH WORKFORCE, AND  
32 CONSUMER PROTECTION.

33       (3) THE DIRECTOR SHALL CONVENE MEETINGS OF THE WORK  
34 GROUP, WHICH SHALL MEET AS OFTEN AS THE DIRECTOR DEEMS  
35 NECESSARY. A MAJORITY OF WORK GROUP MEMBERS MUST BE PRESENT AT  
36 THE MEETING IN ORDER TO PROCEED.

1 (4) THE WORK GROUP IS AUTHORIZED TO MEET USING ONLINE  
2 COMMUNICATIONS PLATFORMS AND MAY MEET IN PERSON AS  
3 CIRCUMSTANCES ALLOW.

4 (5) MEMBERS OF THE WORK GROUP SHALL SERVE WITHOUT  
5 COMPENSATION.

6 (6) ON OR BEFORE JANUARY 1, 2021, THE WORK GROUP SHALL  
7 CONSIDER RECOMMENDATIONS CONCERNING RULEMAKING AND  
8 LEGISLATIVE ACTIONS REGARDING:

9 (a) THE TIMELINE FOR WHICH THE DIVISION SHALL MAKE LETTERS  
10 OF ADMONITION AVAILABLE TO THE PUBLIC AND ANY EXCEPTIONS FOR  
11 CONTINUED INTERNAL USE BY THE APPLICABLE REGULATOR; AND

12 (b) THE TIMELINES, PARAMETERS, AND CONDITIONS FOR WHICH  
13 THE DIVISION IS AUTHORIZED TO DISCLOSE TO THE PUBLIC RECORDS FOR  
14 CERTAIN FELONIES, DEFERRED SENTENCES, OR FELONY CHARGES THAT ARE  
15 NONVIOLENT, INCLUDING NONVIOLENT DRUG OFFENSES, THAT OCCURRED  
16 BEFORE THE DATE OF APPLICATION FOR INITIAL LICENSURE,  
17 CERTIFICATION, OR REGISTRATION.

18 (7) IN CONSIDERING ITS RECOMMENDATIONS, THE WORK GROUP  
19 MUST CONSIDER AND ACCEPT PUBLIC COMMENT REGARDING IMPACTS OF  
20 CURRENT POLICIES ON:

21 (a) CONSUMER PROTECTION;  
22 (b) THE MENTAL HEALTH WORKFORCE;  
23 (c) SOCIAL EQUITY; AND  
24 (d) PATIENT ACCESS TO CARE.

25 (8) THE WORK GROUP SHALL REPORT ITS FINAL  
26 RECOMMENDATIONS AND A MINORITY REPORT, IF APPLICABLE, ON OR  
27 BEFORE JANUARY 1, 2021 TO:

28 (a) THE HEALTH AND HUMAN SERVICES OF THE SENATE, OR ITS  
29 SUCCESSOR COMMITTEE:

30 (b) THE HEALTH AND INSURANCE COMMITTEE AND THE PUBLIC  
31 HEALTH CARE AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF  
32 REPRESENTATIVES, OR THEIR SUCCESSOR COMMITTEES:

33 (c) THE GOVERNOR; AND  
34 (d) THE EXECUTIVE DIRECTOR.

35 (9) THIS SECTION IS REPEALED, EFFECTIVE JUNE 30, 2021.".
