3 THIS SECTION.".

4 Page 6, line 20, strike "AUTHORITY." and substitute "AUTHORITY, IN
5 ACCORDANCE WITH SUBSECTIONS (4)(g) AND (4)(h) OF THIS SECTION.".

6 Page 14, line 25, strike "SECTION; OR" and substitute "SECTION.".

7 Page 14, strike lines 26 and 27 and substitute:
8 "(h) TO RECLASSIFY A HEMP-DERIVED COMPOUND OR
9 CANNABINOID, UNDER SUBSECTION (4)(g) OF THIS SECTION, THE
10 RECLASSIFICATION MUST:
11 (I) BE SUPPORTED BY PEER-REVIEWED RESEARCH OR CLINICAL
12 TRIALS ESTABLISHING TO A REASONABLE DEGREE OF SCIENTIFIC
13 CERTAINTY THAT THE HEMP-DERIVED COMPOUND OR CANNABINOID OR A
14 PRODUCT CONTAINING A HEMP-DERIVED COMPOUND OR CANNABINOID
15 SHOULD BE RECLASSIFIED; OR
16 (II) BE BASED ON A THREAT TO HUMAN HEALTH, INCLUDING
17 SUBSTANTIAL REPORTS OF INTOXICATION OR ADVERSE HEALTH EVENT
18 REPORTS.".

19 Page 15, strike lines 1 through 5.

20 Page 20, line 16, strike "ENVIRONMENT." and substitute "ENVIRONMENT,
21 IN ACCORDANCE WITH SUBSECTIONS (3)(f) AND (3)(e) OF THIS SECTION.".

22 Page 20, line 21, strike "ENVIRONMENT." and substitute "ENVIRONMENT,
23 IN ACCORDANCE WITH SUBSECTIONS (3)(f) AND (3)(e) OF THIS SECTION.".

24 Page 29, line 11, strike "SECTION; OR" and substitute "SECTION.".

25 Page 29, strike lines 12 through 12 and substitute:
26 "(g) TO RECLASSIFY A MARIJUANA-DERIVED COMPOUND OR
27 CANNABINOID, UNDER SUBSECTION (3)(f) OF THIS SECTION, THE
28 RECLASSIFICATION MUST:
29 (I) BE SUPPORTED BY PEER- REVIEWED RESEARCH OR CLINICAL
30 TRIALS ESTABLISHING TO A REASONABLE DEGREE OF SCIENTIFIC
31 CERTAINTY THAT THE MARIJUANA-DERIVED COMPOUND OR CANNABINOID
32 OR A PRODUCT CONTAINING A MARIJUANA-DERIVED COMPOUND OR
33 CANNABINOID SHOULD BE RECLASSIFIED; OR
34 (II) BE BASED ON A THREAT TO HUMAN HEALTH, INCLUDING
35 SUBSTANTIAL REPORTS OF INTOXICATION OR ADVERSE HEALTH EVENT
36 REPORTS.".
