1 Amend reengrossed bill, page 31, before line 9 insert:

2 **SECTION 10.** In Colorado Revised Statutes, 44-10-602, **amend**  
3 (12) as follows:

4 **44-10-602. Retail marijuana cultivation facility license - rules**  
5 **- definitions.** (12) (a) ~~A retail marijuana cultivation facility shall only~~  
6 ~~obtain retail marijuana seeds or immature plants from its own retail~~  
7 ~~marijuana, commonly owned from the medical marijuana of an identical~~  
8 ~~direct beneficial owner, or marijuana that is properly transferred from~~  
9 ~~another retail marijuana business pursuant to the inventory tracking~~  
10 ~~requirements imposed by rule.~~ IN ACCORDANCE WITH THE RULES  
11 PROMULGATED BY THE STATE LICENSING AUTHORITY, A RETAIL  
12 MARIJUANA CULTIVATION FACILITY MAY OBTAIN IMMATURE PLANTS,  
13 MARIJUANA SEEDS, AND MARIJUANA GENETIC MATERIAL, AS GENETIC  
14 MATERIAL IS DEFINED IN RULE OF THE STATE LICENSING AUTHORITY,  
15 FROM:

16 (I) ANOTHER MEDICAL OR RETAIL MARIJUANA CULTIVATION  
17 FACILITY;

18 (II) A RETAIL MARIJUANA TESTING FACILITY;

19 (III) AN ENTITY LICENSED OR OTHERWISE APPROVED TO OPERATE  
20 IN ANOTHER JURISDICTION; OR

21 (IV) ANY OTHER SOURCE PERMITTED BY RULE OF THE STATE  
22 LICENSING AUTHORITY.

23 (b) (I) THE STATE LICENSING AUTHORITY SHALL PROMULGATE  
24 RULES ALLOWING A REGULATED MARIJUANA CULTIVATION FACILITY TO  
25 TRANSFER IMMATURE PLANTS, MARIJUANA SEEDS, AND MARIJUANA  
26 GENETIC MATERIAL, AS GENETIC MATERIAL IS DEFINED IN RULE OF THE  
27 STATE LICENSING AUTHORITY, FROM:

28 (A) ANOTHER MEDICAL OR RETAIL MARIJUANA CULTIVATION  
29 FACILITY;

30 (B) A RETAIL MARIJUANA TESTING FACILITY;

31 (C) AN ENTITY LICENSED OR OTHERWISE APPROVED TO OPERATE  
32 IN ANOTHER JURISDICTION; OR

33 (D) ANY OTHER SOURCE PERMITTED BY RULE OF THE STATE  
34 LICENSING AUTHORITY.

35 (II) THE RULES PROMULGATED UNDER THIS SUBSECTION (12)(b)  
36 MUST INCLUDE INVENTORY TRACKING, REPORTING, AND  
37 RECORDING-KEEPING REQUIREMENTS."

38 Renumber succeeding sections accordingly.
