Second Reading

1 Amend reengrossed bill, page 6, after line 20, insert:

2 "(h) "PHYSICAL SEPARATION" MEANS SEGREGATION OF THE
3 OPERATIONS OF A REGULATED HEMP FACILITY:

4 (I) TO INCLUDE THE PHYSICAL SEPARATION OF HEMP PRODUCTS
5 AND SAFE HARBOR HEMP PRODUCTS DURING THE MANUFACTURE,
6 PRODUCTION, STORAGE, AND DISTRIBUTION OF SAFE HARBOR PRODUCTS;
7 AND

8 (II) THE USE OF SEPARATE EQUIPMENT FOR THE MANUFACTURE OR
9 PRODUCTION OF SAFE HARBOR HEMP PRODUCTS AND HEMP PRODUCTS."

10 Reletter succeeding paragraphs accordingly.

11 Page 9, after line 6, insert:

12 "(III) PROMULGATE RULES CREATING A PROCESS ENSURING NO
13 CROSS CONTAMINATION BETWEEN HEMP PRODUCTS AND SAFE HARBOR
14 HEMP PRODUCTS AND SPECIFYING A SET OF REQUIREMENTS FOR:

15 (A) THE CO-LOCATION OF THE MANUFACTURE OF, PRODUCTION OF,
16 STORAGE OF, AND DISTRIBUTION OF HEMP PRODUCTS AND SAFE HARBOR
17 HEMP PRODUCTS; AND

18 (B) THE USE OF THE SAME EQUIPMENT FOR THE PRODUCTION OF
19 SAFE HARBOR HEMP PRODUCTS AND HEMP PRODUCTS."

20 Renumber succeeding subparagraphs accordingly.

21 Page 16, strike lines 12 through 14 and substitute "FACILITY, UNLESS
22 EACH SAFE HARBOR HEMP PRODUCT:

23 (A) IS PHYSICALLY SEPARATED FROM HEMP PRODUCTS DURING THE
24 MANUFACTURE OF, PRODUCTION, OF STORAGE OF, AND DISTRIBUTION OF
25 THE SAFE HARBOR HEMP PRODUCT;

26 (B) IS MANUFACTURED, PRODUCED, STORED, AND DISTRIBUTED IN
27 ACCORDANCE WITH PROCEDURES THAT IS APPROVED BY THE DEPARTMENT
28 AND THAT ENSURES NO CROSS CONTAMINATION BETWEEN HEMP PRODUCTS
29 AND SAFE HARBOR HEMP PRODUCTS; OR

30 (C) IS MANUFACTURED, PRODUCED, STORED, AND DISTRIBUTED IN
31 ACCORDANCE WITH RULES OF THE DEPARTMENT PROMULGATED IN
32 ACCORDANCE WITH SUBSECTION (3)(e)(III) OF THIS SECTION."
