SB20-033 be amended as follows:

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, 25.5-6-1403, add
3 (5) as follows:

4 **25.5-6-1403. Waivers and amendments.** (5) (a) THE STATE
5 DEPARTMENT SHALL SEEK FEDERAL AUTHORIZATION THROUGH AN
6 AMENDMENT TO THE STATE MEDICAL ASSISTANCE PLAN TO IMPLEMENT
7 THE FEDERAL "BALANCED BUDGET ACT OF 1997", PUB.L. 105-33, 111, AS
8 AMENDED, WHICH PROVIDES INDIVIDUALS AN OPPORTUNITY TO BUY INTO
9 MEDICAID CONSISTENT WITH THE FEDERAL "SOCIAL SECURITY ACT", 42
10 U.S.C. SEC. 1396a (a)(10)(A)(ii)(XIII), AS AMENDED, TO PERMIT THE
11 STATE DEPARTMENT TO PROVIDE MEDICAL ASSISTANCE ELIGIBILITY TO
12 INDIVIDUALS IN THE WORK INCENTIVES ELIGIBILITY GROUP, AGE
13 SIXTY-FIVE AND OLDER, AFTER THEY ARE NO LONGER ELIGIBLE UNDER THE
14 FEDERAL "TICKET TO WORK AND WORK INCENTIVES IMPROVEMENT ACT
15 OF 1999", PUB.L. 106-170.

16 (b) IN ADDITION TO SUBMITTING AN AMENDMENT TO THE STATE
17 MEDICAL ASSISTANCE PLAN PURSUANT TO SUBSECTION (5)(a) OF THIS
18 SECTION, THE STATE DEPARTMENT SHALL SUBMIT A STATE PLAN
19 AMENDMENT PURSUANT TO SECTION 1902(r)(2) OF THE FEDERAL "SOCIAL
20 SECURITY ACT" TO USE LESS RESTRICTIVE INCOME AND RESOURCE
21 METHODOLOGIES TO MATCH THE INCOME, HOUSEHOLD, AND ASSET LEVELS
22 OF THE MEDICAID BUY-IN PROGRAM FOR IMPLEMENTATION NO LATER THAN
23 JULY 1, 2021."
