

## SENATE FLOOR AMENDMENT

Third Reading

1 Amend revised bill, page 3, after line 25, insert:

2       "(c) "BIOMETRIC TECHNOLOGY" MEANS A TECHNOLOGY THAT  
3 USES, COLLECTS, OR ANALYZES DATA GENERATED BY THE TECHNOLOGICAL  
4 PROCESSING, MEASUREMENT, OR ANALYSIS OF AN INDIVIDUAL'S  
5 BIOLOGICAL, PHYSICAL, OR BEHAVIORAL CHARACTERISTICS, WHICH DATA  
6 CAN BE PROCESSED FOR THE PURPOSE OF UNIQUELY IDENTIFYING AN  
7 INDIVIDUAL."

8 Reletter succeeding paragraphs accordingly.

9 Page 7, line 14, strike "AND".

10 Page 7, line 16, strike "GOVERNOR." and substitute "GOVERNOR; AND  
11 (XXVI) ONE MEMBER WHO IS AN EXPERT IN FINANCE AND  
12 FINANCIAL TECHNOLOGY, TO BE APPOINTED BY THE GOVERNOR."

13 Page 7, line 17, after "(c)" insert "(I)".

14 Page 7, after line 21 insert:

15       "(II) BEFORE AUGUST 1, 2024, THE PRESIDENT OF THE SENATE  
16 SHALL APPOINT THE CHAIR OF THE TASK FORCE AND THE SPEAKER OF THE  
17 HOUSE OF REPRESENTATIVES SHALL APPOINT THE VICE-CHAIR OF THE TASK  
18 FORCE. THEREAFTER, THE CHAIR OF THE TASK FORCE SHALL BE APPOINTED  
19 ANNUALLY ON OR BEFORE JULY 1, WITH THE SPEAKER OF THE HOUSE OF  
20 REPRESENTATIVES APPOINTING THE CHAIR IN ODD-NUMBERED YEARS AND  
21 THE PRESIDENT OF THE SENATE APPOINTING THE CHAIR IN  
22 EVEN-NUMBERED YEARS."

23 Page 10, line 5, strike "AND".

24 Page 10, line 9, strike "DISCRIMINATION." and substitute  
25 "DISCRIMINATION; AND

26       (j) DEVELOPING RECOMMENDATIONS RELATED TO THE USE OF  
27 FACIAL RECOGNITION SERVICES AND BIOMETRIC TECHNOLOGY."

28 Page 10, strike lines 11 through 13 and substitute "IS APPOINTED AS CHAIR  
29 OF THE TASK FORCE PURSUANT TO SUBSECTION (2)(c)(II) OF THIS SECTION  
30 SHALL CALL THE FIRST MEETING OF THE TASK FORCE."

31 Page 10, strike lines 16 and 17.

- 1 Page 10, line 18, strike "SIX" and substitute "FIVE".
- 2 Page 10, line 24, strike "APRIL 1," and substitute "FEBRUARY 1,".
- 3 Page 11, after line 5, insert:
  - 4 "(e) THE TASK FORCE SHALL CONTINUE TO MEET AS NECESSARY
  - 5 AFTER IT SUBMITS THE REPORT REQUIRED BY SUBSECTION (4)(c) OF THIS
  - 6 SECTION, AS DETERMINED BY THE TASK FORCE, UNTIL THE TASK FORCE IS
  - 7 SCHEDULED FOR REVIEW PURSUANT TO SUBSECTION (6) OF THIS SECTION."
- 8 Page 12, strike lines 4 through 6.
- 9 Renumber succeeding section accordingly.
