- 2 actions," and substitute "~~medical malpractice actions~~".

- 3 Page 3, line 17, strike "A MALPRACTICE ACTION,", and strike "2026" and
- 4 substitute "2025".

- 5 Page 3, lines 26 and 27, strike "a medical malpractice action," and
- 6 substitute "~~a medical malpractice action~~".

- 7 Page 8, line 3, strike "DOLLARS," and substitute "DOLLARS IN ANY
- 8 WRONGFUL DEATH ACTION OR BINDING ARBITRATION FILED ON OR AFTER
- 9 JANUARY 1, 2025, AND BEFORE JANUARY 1, 2026, OR ANY WRONGFUL
- 10 DEATH CLAIM THAT ACCRUES ON OR AFTER JANUARY 1, 2025, IN WHICH
- 11 DAMAGES FOR DERIVATIVE OR DIRECT NONECONOMIC LOSS OR INJURY
- 12 MAY BE AWARDED,".

- 13 Page 8, line 16, strike "DOLLARS," and substitute "DOLLARS IN ANY
- 14 WRONGFUL DEATH ACTION OR BINDING ARBITRATION FILED ON OR AFTER
- 15 JANUARY 1, 2025, AND BEFORE JANUARY 1, 2026, OR ANY WRONGFUL
- 16 DEATH CLAIM THAT ACCRUES ON OR AFTER JANUARY 1, 2025, IN WHICH
- 17 DAMAGES FOR DERIVATIVE OR DIRECT NONECONOMIC LOSS OR INJURY
- 18 MAY BE AWARDED,".

- 19 Page 8, line 19, after the period add "DAMAGES ARISING FROM CLAIMS
- 20 BROUGHT AGAINST A PUBLIC ENTITY OR PUBLIC EMPLOYEE, AS DEFINED IN
- 21 SECTION 24-10-103, SHALL BE CONTROLLED BY THE DAMAGE LIMITATIONS
- 22 SET FORTH IN SECTION 24-10-114.".

- 23 Page 10, after line 25, insert:

24 "(VII) THE LIMITATIONS OF SUBSECTION (1)(b)(I) OF THIS SECTION
25 ARE NOT APPLICABLE TO A HEALTH-CARE PROFESSIONAL WHO IS A PUBLIC
26 EMPLOYEE UNDER THE "COLORADO GOVERNMENTAL IMMUNITY ACT"
27 AND ARE NOT APPLICABLE TO A CERTIFIED HEALTH-CARE INSTITUTION
28 THAT IS A PUBLIC ENTITY UNDER THE "COLORADO GOVERNMENTAL
29 IMMUNITY ACT".".

31 and 27; **Page 9**, lines 1, 11, and 21; **Page 10**, lines 4 and 15.
