Summary Information

Overview. The bill requires health care providers to offer their pregnant patients the option to fill out a "do not abort" form.

Types of impacts. The bill is projected to affect the following areas on an ongoing basis:

Summary of Legislation

The bill requires health care providers to offer their pregnant patients the option to fill out a "do not abort" form that expresses the patient's wishes to not receive an abortion in the event of incapacitation. If the form is filled out, the health care provider must enter it into the patient's medical record.

State Expenditures

The bill minimally increases workload in the Department of Regulatory Agencies and the Department of Public Health and Environment (CDPHE) to conduct outreach and education to medical professionals and health care facilities. The CDPHE may also require legal services, provided by the Department of Law, related to rulemaking. This workload is expected to be minimal and can be accomplished within existing appropriations.

If the bill results in fewer abortions for Medicaid members, state expenditures will increase in the Department of Health Care Policy and Financing as a net result of decreased costs for abortion care services, and increased labor and delivery costs. However, it is assumed that most pregnant individuals have already made and communicated decisions regarding pregnancy termination with their health care providers; therefore, these impacts are expected to be minimal.

Effective Date

The bill takes effect 90 days following adjournment of the General Assembly sine die, assuming no referendum petition is filed.
