A BILL FOR AN ACT

101 **CONCERNING FUNDING FOR CAPITAL CONSTRUCTION, AND MAKING**
102 **SUPPLEMENTAL APPROPRIATIONS IN CONNECTION THEREWITH.**

Bill Summary

1 **SECTION 1. Capital construction appropriations for the**
2 **fiscal year beginning July 1, 2022.** In Session Laws of Colorado 2022,
3 section 3 of chapter 507, (HB 22-1329), **amend** Part II (1)(B), Part III
4 (2)(B), and the affected totals, as the affected totals are amended by
5 section 1 of chapter 473, (SB 23-135), Session Laws of Colorado 2023;
6 as the Part III affected totals are amended by section 2 of chapter 517,
7 (HB 24-1203), as the Part II affected totals are amended by section 32 of
8 chapter 257, (HB 24-1465), and as Part II (1)(B) and Part III (2)(B) are
9 amended by section 82 of chapter 429, (HB 24-1466), Session Laws of
10 Colorado 2024; as Part III and the affected totals are further amended by,
