A BILL FOR AN ACT

101 CONCERNING THE ABILITY OF A HEALTH SERVICE DISTRICT TO
102 PROVIDE AFFORDABLE HOUSING SERVICES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, a special district is required to conform to its approved service plan and must petition the governing body of the county or municipality that approved the formation of the special district for approval of any material modifications of its approved service plan. Material modifications include a change in services provided by the special district, a decrease in the financial ability of the district to

discharge existing or proposed indebtedness, and a decrease in the existing or projected need for organized service in the district's service area. The court that approved the organization of the special district may enjoin any material departure from the district's service plan as originally approved or from the district's service plan as modified.

In the case of a health service district, a change in service by the district is not a material modification to or departure from the district's approved service plan, unless the change affects the license or certificate of compliance issued to the district by the department of public health and environment. The bill expands this provision to provide that the addition of affordable housing services to a health service district's service plan is not a material modification to or departure from the district's approved service plan so long as a majority of the board of directors of the district affirmatively votes to approve the addition of affordable housing services. With this change, a health service district is able to provide affordable housing services, which are defined as the planning, financing, acquisition, construction, reconstruction or repair, maintenance, management, and operation of affordable housing-related projects or programs, without needing to seek approval for a material modification to or departure from the district's approved service plan.

The bill also makes conforming amendments.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 32-1-207, **amend** (4)
3 as follows:

4 **32-1-207. Compliance - modification - enforcement.**

5 (4) (a) In the case of a health service district, a change in service
6 by the district is not deemed material unless the change affects the license
7 or certificate of compliance issued by the department of public health and
8 environment.

9 (b) IN THE CASE OF A HEALTH SERVICE DISTRICT, THE ADDITION OF
10 AFFORDABLE HOUSING SERVICES, AS DEFINED IN SECTION 32-19-102 (2),
11 TO THE SERVICES PROVIDED BY THE DISTRICT IS NOT A MATERIAL
12 MODIFICATION TO OR DEPARTURE FROM THE DISTRICT'S APPROVED
13 SERVICE PLAN SO LONG AS A MAJORITY OF THE BOARD OF DIRECTORS OF

1 THE DISTRICT AFFIRMATIVELY VOTES TO APPROVE THE ADDITION OF
2 AFFORDABLE HOUSING SERVICES.

3 (c) A health service district is exempt from subsection (3)(b) and
4 (3)(c) of this section.

5 **SECTION 2.** In Colorado Revised Statutes, 32-1-1003, **amend**
6 (1)(c), (5) introductory portion, and (5)(a); and **add** (1)(b.5) as follows:

7 **32-1-1003. Health service districts - additional powers.**

8 (1) In addition to the powers specified in section 32-1-1001, the
9 board of any health service district has any or all of the following powers
10 for and on behalf of such district:

11 (b.5) TO PROVIDE AFFORDABLE HOUSING SERVICES, AS DEFINED IN
12 SECTION 32-19-102 (2);

13 (c) To draw warrants against health service district funds held by
14 the county treasurer for the purposes set forth in ~~paragraphs (a) and (b) of~~
15 ~~this subsection (1)~~ SUBSECTIONS (1)(a), (1)(b), AND (1)(b.5) OF THIS
16 SECTION;

17 (5) Any health service district that is created pursuant to this
18 article shall have the power, upon approval by the eligible electors of the
19 district, to levy and collect a uniform sales tax throughout the entire
20 geographic area of the district upon every transaction or other incident
21 with respect to which a sales tax is levied by the state pursuant to the
22 provisions of article 26 of title 39, ~~C.R.S.~~, excluding the sale of cigarettes,
23 subject to the following provisions:

24 (a) For purposes of this subsection (5), "eligible elector" ~~shall~~
25 ~~have~~ HAS the same meaning as set forth in ~~section 32-19-102 (3)~~ SECTION
26 32-19-102 (5).

27 **SECTION 3.** In Colorado Revised Statutes, 32-1-1003.5, **amend**

1 (5)(a) as follows:

2 **32-1-1003.5. Health assurance districts - additional powers -**
3 **legislative declaration - definitions.**

4 (5) Any health assurance district that is created pursuant to this
5 article 1 shall have the power, upon approval by the eligible electors of
6 the district, to levy and collect a uniform sales tax throughout the entire
7 geographic area of the district upon every transaction or other incident
8 with respect to which a sales tax is levied by the state pursuant to the
9 provisions of article 26 of title 39, excluding the sale of cigarettes, subject
10 to the following provisions:

11 (a) For purposes of this subsection (5), "eligible elector" ~~shall~~
12 ~~have~~ HAS the same meaning as set forth in ~~section 32-19-102 (3)~~ SECTION
13 32-19-102 (5).

14 **SECTION 4.** In Colorado Revised Statutes, **amend** 32-19-102 as
15 follows:

16 **32-19-102. Definitions.**

17 As used in this ~~article~~ ARTICLE 19, unless the context otherwise
18 requires:

19 (1) "AFFORDABLE HOUSING" MEANS:

20 (a) FOR A HOUSEHOLD RESIDING IN HOUSING ON A RENTAL BASIS,
21 ANNUAL INCOME OF THE HOUSEHOLD IS AT OR BELOW ONE HUNDRED
22 TWENTY PERCENT OF THE AREA MEDIAN INCOME OF HOUSEHOLDS OF THAT
23 SIZE IN THE COUNTY IN WHICH THE HOUSING IS LOCATED;

24 (b) FOR A HOUSEHOLD RESIDING IN HOUSING ON A HOME
25 OWNERSHIP BASIS, ANNUAL INCOME OF THE HOUSEHOLD AT OR BELOW ONE
26 HUNDRED TWENTY PERCENT OF THE AREA MEDIAN INCOME OF
27 HOUSEHOLDS OF THAT SIZE IN THE COUNTY IN WHICH THE HOUSING IS

1 LOCATED; OR

2 (c) FOR A HOUSEHOLD RESIDING IN HOUSING ON A HOME
3 OWNERSHIP BASIS IN A RURAL RESORT COUNTY, ANNUAL INCOME OF THE
4 HOUSEHOLD IS AT OR BELOW ONE HUNDRED SIXTY PERCENT OF THE AREA
5 MEDIAN INCOME OF HOUSEHOLDS OF THAT SIZE IN THE COUNTY IN WHICH
6 THE HOUSING IS LOCATED.

7 (2) "AFFORDABLE HOUSING SERVICES" MEANS THE PLANNING,
8 FINANCING, ACQUISITION, CONSTRUCTION, RECONSTRUCTION OR REPAIR,
9 MAINTENANCE, MANAGEMENT, AND OPERATION OF AFFORDABLE
10 HOUSING-RELATED PROJECTS OR PROGRAMS.

11 (3) "Court" means the district court in any county in which the
12 petition for organization of the district was originally filed and which
13 entered the order organizing said district or the district court to which the
14 file pertaining to the district has been transferred pursuant to section
15 32-1-303 (1)(b).

16 (4) "District" means:

17 (a) A health assurance district created pursuant to this ~~article~~
18 ARTICLE 19 to organize, operate, control, direct, manage, contract for,
19 furnish, or provide, directly or indirectly, health-care services to residents
20 of the district who are in need of such services; or

21 (b) A health service district created pursuant to this ~~article~~
22 ARTICLE 19 that may establish, maintain, or operate, directly or indirectly
23 through lease to or from other parties or other arrangement, public
24 hospitals, convalescent centers, nursing care facilities, intermediate care
25 facilities, emergency facilities, community clinics, or other facilities
26 providing health and personal care services and may organize, own,
27 operate, control, direct, manage, contract for, or furnish ambulance

1 service.

2 ~~(3)~~ (5) "Eligible elector" means a person who, at the designated
3 time or event, is registered to vote pursuant to the "Uniform Election
4 Code of 1992", articles 1 to 13 of title 1. ~~C.R.S.~~

5 ~~(4)~~ (6) "Interested party" means a resident or eligible elector of the
6 district or a municipality located in the district.

7 **SECTION 5.** In Colorado Revised Statutes, 32-19-108, **amend**
8 (3) and (4) as follows:

9 **32-19-108. Public hearing on service plan - procedures -**
10 **decision - judicial review - modifications - enforcement.**

11 (3) The board of county commissioners of the county in which the
12 district will be located or the governing body of the municipality in which
13 the district will be located, whichever is applicable, shall conduct the
14 hearing pursuant to section 32-1-204 (1.5) and make its decision in
15 accordance with the requirements of section 32-1-204 (3) and (4). The
16 decision of the board or governing body, whichever is applicable, is
17 subject to judicial review in accordance with section 32-1-206; except
18 that, for purposes of judicial review, "interested party" ~~shall have~~ HAS the
19 ~~same~~ meaning as set forth in ~~section 32-19-102 (4)~~ SECTION 32-19-102
20 (6).

21 (4) Upon final approval by the court for the organization of a
22 district pursuant to section 32-1-304.5, the district shall conform as much
23 as possible to the approved service plan, and any material modifications
24 to the plan shall be approved in accordance with ~~section 32-1-207 (2)~~
25 SECTION 32-1-207 (2) AND (4). Any material departure from the plan may
26 be enjoined in accordance with section 32-1-207 (3); except that, for
27 purposes of enforcement of the plan, "interested party" ~~shall have~~ HAS the

1 same meaning as set forth in ~~section 32-19-102 (4)~~ SECTION 32-19-102
2 (6).

3 **SECTION 6.** In Colorado Revised Statutes, 32-19-110, **amend**
4 (2) as follows:

5 **32-19-110. Time for holding elections - persons entitled to vote**
6 **at district elections.**

7 (2) Notwithstanding the provisions of section 32-1-806, any
8 person who is an eligible elector as defined in ~~section 32-19-102 (3)~~
9 SECTION 32-19-102 (5) shall be eligible to vote in an organizational
10 election or any election conducted by the board of directors for a district.

11 **SECTION 7. Act subject to petition - effective date.** This act
12 takes effect at 12:01 a.m. on the day following the expiration of the
13 ninety-day period after final adjournment of the general assembly (August
14 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
15 referendum petition is filed pursuant to section 1 (3) of article V of the
16 state constitution against this act or an item, section, or part of this act
17 within such period, then the act, item, section, or part will not take effect
18 unless approved by the people at the general election to be held in
19 November 2026 and, in such case, will take effect on the date of the
20 official declaration of the vote thereon by the governor.
