A BILL FOR AN ACT

101 **CONCERNING NONEMERGENCY MEDICAL TRANSPORTATION SERVICES**

102 **FOR MEDICAID MEMBERS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires a transportation broker to contract with at least 5 transportation providers to provide nonemergency transportation services to medicaid members.

A transportation provider must meet certain requirements before providing transportation services.

The bill requires that medicaid members be able to preapprove

nonemergency medical transportation services and choose a preferred transportation provider to receive nonemergency transportation services through.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25.5-1-802, **add** (4)
3 as follows:

4 **25.5-1-802. Medicaid transportation services - safety and**
5 **oversight - rules.**

6 (4) (a) A TRANSPORTATION BROKER SHALL CONTRACT WITH AT
7 LEAST FIVE TRANSPORTATION PROVIDERS TO PROVIDE TRANSPORTATION
8 SERVICES TO MEMBERS.

9 (b) A TRANSPORTATION PROVIDER SHALL:

10 (I) HAVE AT LEAST THREE YEARS OF TRANSPORTATION
11 EXPERIENCE;

12 (II) OPERATE A DISPATCH CENTER WITH DRIVER MONITORING
13 CAPABILITIES;

14 (III) MAINTAIN A PHYSICAL OFFICE SPACE THAT IS SUITABLE FOR
15 PROVIDING TRANSPORTATION SERVICES;

16 (IV) MAINTAIN A WEBSITE TO ACCOMMODATE ONLINE BOOKING;
17

18 (V) IMPLEMENT A DRIVER TRAINING PROGRAM, VEHICLE
19 INSPECTIONS, AND A SUBSTANCE USE TESTING PROGRAM FOR DRIVERS;

20 (VI) HANDLE ALL SCHEDULING, TRANSPORTATION, AND
21 BILLING FOR TRANSPORTATION SERVICES PROVIDED BY THE
22 TRANSPORTATION PROVIDER;

23 (VII) MAINTAIN DETAILED RECORDS OF OPERATION AND
24 REGISTRATIONS OR CREDENTIALS THE TRANSPORTATION PROVIDER IS

1 REQUIRED TO COMPLY WITH AND WORK WITH THE TRANSPORTATION
2 PROVIDER AND THE STATE DEPARTMENT TO PROVIDE TRANSPORTATION
3 SERVICES;

4 (VIII) CONDUCT THE ANNUAL PERFORMANCE REVIEW;

5 (IX) PROMPTLY ADDRESS AND RESOLVE ALL CLIENT COMPLAINTS;

6 AND

7 (X) MAINTAIN AND UTILIZE A DAILY INSPECTION SHEET FOR
8 VEHICLES USED TO PROVIDE TRANSPORTATION SERVICES.

9 (c) UPON RECEIPT OF A CLAIM FOR PAYMENT FOR NONEMERGENCY
10 MEDICAL TRANSPORTATION TRIPS OF FIFTY-TWO MILES OR MORE, THE
11 STATE DEPARTMENT MUST ISSUE PAYMENT TO THE TRANSPORTATION
12 PROVIDER THAT PROVIDED THE NONEMERGENCY MEDICAL
13 TRANSPORTATION SERVICES WITHIN FOURTEEN CALENDAR DAYS AFTER
14 RECEIVING THE CLAIM FOR PAYMENT.

15 (d) A TRANSPORTATION BROKER SHALL ANNUALLY CONDUCT A
16 PERFORMANCE REVIEW OF EACH TRANSPORTATION PROVIDER THE
17 TRANSPORTATION BROKER CONTRACTS WITH TO PROVIDE
18 TRANSPORTATION SERVICES TO MEMBERS.

19 (e) A MEMBER WHO UTILIZES NONEMERGENCY MEDICAL
20 TRANSPORTATION SERVICES MUST BE ABLE TO PREAPPROVE
21 NONEMERGENCY MEDICAL TRANSPORTATION AND CHOOSE A PREFERRED
22 TRANSPORTATION PROVIDER TO RECEIVE NONEMERGENCY
23 TRANSPORTATION SERVICES THROUGH.

24 (f) DISPUTES THAT ARISE BETWEEN A TRANSPORTATION PROVIDER
25 AND THE TRANSPORTATION BROKER OR MEMBER MAY BE ADJUDICATED BY
26 THE STATE DEPARTMENT IN ACCORDANCE WITH SECTION 24-4-105.

27 (g) THE STATE DEPARTMENT MAY ADOPT RULES AS NECESSARY TO

1 IMPLEMENT THIS SUBSECTION (4).

2 (h) THIS SUBSECTION (4) DOES NOT APPLY TO AN EMERGENCY
3 MEDICAL SERVICES PROVIDER THAT PROVIDES NONEMERGENCY MEDICAL
4 TRANSPORTATION SERVICES TO MEMBERS.

5 **SECTION 2. Safety clause.** The general assembly finds,
6 determines, and declares that this act is necessary for the immediate
7 preservation of the public peace, health, or safety or for appropriations for
8 the support and maintenance of the departments of the state and state
9 institutions.
