A BILL FOR AN ACT

101 **CONCERNING A PROHIBITION ON A MEMBER _____ OF THE GENERAL**
102 **ASSEMBLY HOLDING MULTIPLE ELECTED OFFICES.**

Bill Summary

The bill prohibits a member or member-elect of the general assembly from holding any other elected offices while serving as a member of the general assembly or while a member-elect of the general assembly.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add 2-2-328** as
3 follows:

4 **2-2-328. Members of the general assembly prohibited from**
5 **holding multiple elected offices.**

6 (1) COMMENCING WITH THE FIRST REGULAR SESSION OF THE
7 SEVENTY-SIXTH GENERAL ASSEMBLY, AND DURING EACH REGULAR
8 SESSION THEREAFTER, EXCEPT AS PROVIDED IN SUBSECTION (2) OF THIS
9 SECTION, A MEMBER OF THE GENERAL ASSEMBLY SHALL NOT HOLD ANY
10 OTHER ELECTED OFFICE WHILE SERVING AS A MEMBER OF THE GENERAL
11 ASSEMBLY. THIS SECTION APPLIES TO A MEMBER OF THE GENERAL
12 ASSEMBLY UPON TAKING THE OATH OF OFFICE OF THE GENERAL ASSEMBLY
13 AS REQUIRED BY SECTION 2 (2) OF ARTICLE V OF THE STATE
14 CONSTITUTION.

15 (2) THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION DO NOT
16 APPLY IF:

17 (a) THE MEMBER OF THE GENERAL ASSEMBLY HOLDS A SPECIAL
18 DISTRICT ELECTED OFFICE;

19 (b) THE MEMBER OF THE GENERAL ASSEMBLY HAS LESS THAN ONE
20 YEAR REMAINING IN THEIR TERM IN ANOTHER ELECTED OFFICE AT THE
21 TIME THE MEMBER TAKES THE OATH OF OFFICE OF THE GENERAL
22 ASSEMBLY AS REQUIRED BY SECTION 2 (2) OF ARTICLE V OF THE STATE
23 CONSTITUTION;

24 (c) THE MEMBER OF THE GENERAL ASSEMBLY HAS LESS THAN ONE
25 YEAR REMAINING IN THEIR TERM IN THE GENERAL ASSEMBLY AT THE TIME
26 THE MEMBER TAKES THE OATH OF OFFICE OF ANOTHER ELECTED OFFICE;
27 OR

1 (d) THE MEMBER OF THE GENERAL ASSEMBLY IS A SENATOR WHO
2 IS IN THE MIDDLE OF THEIR TERM AT THE BEGINNING OF THE FIRST
3 REGULAR SESSION OF THE SEVENTY-SIXTH GENERAL ASSEMBLY.

4 **SECTION 2. Safety clause.** The general assembly finds,
5 determines, and declares that this act is necessary for the immediate
6 preservation of the public peace, health, or safety or for appropriations for
7 the support and maintenance of the departments of the state and state
8 institutions.
