### CONCERNING THE RECOGNITION OF CAREGIVING YOUTH DAY.

WHEREAS, Caregiving youth are children and adolescents under eighteen years old who provide primary or secondary care to a family member or loved one of any age who has a chronic illness, frailty of aging, disability, mental health condition, or other health-related need requiring regular assistance; and

WHEREAS, It is estimated that more than six million caregiving youth nationwide provide essential care while also balancing school, extracurricular activities, employment, sibling care, and their own physical, emotional, and social development; and

WHEREAS, The most recent data from the Healthy Kids Colorado Survey shows that 12.3% of high schoolers and 20.4% of middle schoolers identify as caregivers, with as many as 31.03% of children shouldering caregiving responsibilities in some districts; and

WHEREAS, Caregiving youth often perform adult-level responsibilities, including personal care, medication management, household tasks, emotional support, and care coordination, frequently without formal recognition or support; and

WHEREAS, Caregiving youth are at increased risk of academic challenges, absenteeism, stress, anxiety, substance misuse, and social isolation, yet remain largely underidentified and underserved within education, health care, and social service systems; and

WHEREAS, Caregiving youth contribute significantly to the stability and well-being of their families and communities, often at great personal sacrifice and must navigate difficult situations that are no fault of their own; and

WHEREAS, Increasing awareness of caregiving youth is essential to promoting early identification, appropriate accommodations, trauma-informed supports, and improved outcomes for these young people; and

WHEREAS, February 20, 2026, is designated as Caregiving Youth Day, and Colorado will formally observe Caregiving Youth Day on February 27, 2026, at the Colorado state capitol; now, therefore,

*Be It Resolved by the House of Representatives of the Seventy-fifth General Assembly of the State of Colorado, the Senate concurring herein:*

(1) That February 20, 2026, is hereby recognized as Caregiving Youth Day in Colorado, with official observance taking place on February 27, 2026;

(2) That the General Assembly honors and recognizes caregiving youth across Colorado for their compassion, resilience, and contributions to their families and communities;

(3) That the General Assembly honors and recognizes caregiving youth as an underserved and underrecognized population deserving of increased awareness, understanding, and support;

(4) That educators, school districts, health-care providers, policymakers, and community organizations are encouraged to identify caregiving youth and consider appropriate accommodations, resources, and trauma-informed supports; and


(5) Colorado supports continued research, data collection, and collaborative initiatives to better understand and respond to the needs of caregiving youth.
