WHEREAS, Colorado has long been a national leader in winter sports, with world-class mountain terrain, training facilities, and a strong outdoor recreation culture that help develop athletes capable of competing on the international stage; and

WHEREAS, Athletes from Colorado who qualified for the 2026 Olympic and Paralympic Winter Games demonstrate extraordinary dedication, discipline, and resilience, often training for years while balancing education, employment, and commitments to their families and communities; and

WHEREAS, While wearing the uniform of the United States of America and competing before a global audience, Colorado's Olympic and Paralympic athletes proudly represent our nation with honor and distinction, serving as ambassadors for American values including perseverance, teamwork, fair competition, and respect for others while also representing the state of Colorado and their hometowns, many of them rural and mountain communities; and


*Be It Resolved by the Senate of the Seventy-fifth General Assembly of the State of Colorado, the House of Representatives concurring herein:*
