101 **CONCERNING COMPENSABLE LOSSES UNDER THE "COLORADO CRIME**

Bill Summary

The bill allows eligible enrolled members of a federally recognized tribe to receive compensation for traditional Native American healing ceremonies and practices and related expenses under the "Colorado Crime Victim Compensation Act".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-4.1-109, **amend**
3 **(1)(k); and add (1)(m) and (1)(n) as follows:**

10 (m) EXPENSES FOR TRADITIONAL NATIVE AMERICAN HEALING
11 CEREMONIES AND PRACTICES FOR ENROLLED MEMBERS OF A FEDERALLY
12 RECOGNIZED TRIBE, INCLUDING:

13 (I) TRADITIONAL COUNSELING AND HEALING FROM AN ELDER OR
14 SPIRITUAL HEALER;

15 (II) SWEAT LODGE AND SMUDGING CEREMONIES;

16 (III) CEREMONIAL BURIALS, INCLUDING CLOTHING FOR THE
17 DECEASED, MEALS, AND OTHER EXPENSES RELATED TO TRADITIONAL
18 GIVEAWAY OR GIFTING PRACTICES;

19 (IV) CHILD CARE DURING BURIAL CEREMONIES; AND

20 (V) REIMBURSEMENT FOR GIFTS TO INDIVIDUALS WHO PERFORM
21 CEREMONIAL SERVICES; AND

22 (n) REASONABLE TRAVEL EXPENSES RELATED TO TRADITIONAL
23 NATIVE AMERICAN HEALING CEREMONIES AND PRACTICES, AS DESCRIBED
24 IN SUBSECTION (1)(m) OF THIS SECTION, FOR A VICTIM WHO IS AN
25 ENROLLED MEMBER OF A FEDERALLY RECOGNIZED TRIBE.

26 **SECTION 2. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the
2 ninety-day period after final adjournment of the general assembly (August
3 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
4 referendum petition is filed pursuant to section 1 (3) of article V of the
5 state constitution against this act or an item, section, or part of this act
6 within such period, then the act, item, section, or part will not take effect
7 unless approved by the people at the general election to be held in
8 November 2026 and, in such case, will take effect on the date of the
9 official declaration of the vote thereon by the governor.
