**A BILL FOR AN ACT**

101 **CONCERNING MODIFICATIONS TO SELECT STATUTORY PROVISIONS TO**  
102 **IMPROVE TRANSPORTATION SAFETY.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)*

The bill makes the following changes to statutes to improve transportation and traffic safety:

- Clarifies tire, chain, and alternate traction device requirements on a state highway by removing references to four-wheel and all-wheel drive (**section 1** of the bill);
- Prohibits an individual from stopping, standing, or parking

a vehicle in the portion of a roadway designated as a bike lane, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or an official traffic control device (**section 2**);

- Clarifies that specified officers and authorized employees may move an attended or unattended motor vehicle, vehicle, cargo, or debris that is on a highway right-of-way and that obstructs or impedes traffic or highway maintenance or operations (**section 3**); and
- Updates statutory references relating to vehicle or traffic collisions or collisions involving other transportation devices in titles 13, 16, 18, 24, 25, 30, 32, 33, 40, 41, 42, 43, and 44 to use the term "crash" or "incident" in addition to or in place of the term "accident" (**sections 4 through 95**).

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 42-4-106, **amend**  
3 (5)(a)(I)(B) as follows:

4           **42-4-106. Who may restrict right to use highways - definitions**  
5 **- rules.**

6           (5) (a) (I) (B) When icy or snow-packed conditions exist on the  
7 highway, the department of transportation may restrict travel on or use of  
8 any portion of a state highway by a motor vehicle unless the motor  
9 vehicle is equipped with the following: Tire chains or an alternate traction  
10 device; ~~four-wheel drive with~~ OR tires that have a tread depth of at least  
11 three sixteenths of an inch and that are imprinted by a manufacturer with  
12 a mountain-snowflake, "M&S", "M+S", or "M/S" symbol or that are  
13 all-weather rated by the manufacturer. ~~or all-wheel drive with tires that~~  
14 ~~have a tread depth of at least three sixteenths of an inch and that are~~  
15 ~~imprinted by a manufacturer with a mountain-snowflake, "M&S", "M+S",~~  
16 ~~or "M/S" symbol or that are all-weather rated by the manufacturer.~~

17           **SECTION 2.** In Colorado Revised Statutes, 42-4-1204, **add**

1 (1)(j.5) as follows:

2 **42-4-1204. Stopping, standing, or parking prohibited in**  
3 **specified places - penalty.**

4 (1) Except as otherwise provided in subsection (4) of this section,  
5 no person shall stop, stand, or park a vehicle, except when necessary to  
6 avoid conflict with other traffic or in compliance with the directions of a  
7 police officer or an official traffic control device, in any of the following  
8 places:

9 (j.5) IN THE PORTION OF A ROADWAY DESIGNATED AS A BIKE LANE;

10 **SECTION 3.** In Colorado Revised Statutes, 42-4-1803, **amend**  
11 (2) as follows:

12 **42-4-1803. Abandonment of motor vehicles - public property.**

13 (2) Whenever any sheriff, undersheriff, deputy sheriff, police  
14 officer, marshal, Colorado state patrol officer, agent of the Colorado  
15 bureau of investigation, or agency employee finds a motor vehicle,  
16 vehicle, cargo, or debris, attended or unattended, standing upon any  
17 portion of a highway right-of-way in such a manner as to constitute an  
18 obstruction OR IMPEDIMENT to traffic or proper highway maintenance OR  
19 OPERATIONS, such officer or agency employee is authorized to cause the  
20 motor vehicle, vehicle, cargo, or debris to be moved to eliminate any such  
21 obstruction OR IMPEDIMENT; and neither the officer, the agency employee,  
22 nor anyone acting under the direction of such officer or employee ~~shall~~  
23 ~~be~~ IS liable for any damage to such motor vehicle, vehicle, cargo, or  
24 debris occasioned by such removal. The removal process is intended to  
25 clear the obstruction OR IMPEDIMENT, but such activity should create as  
26 little damage as possible to the vehicle, or cargo, or both. ~~No~~ AN agency  
27 employee shall NOT cause any motor vehicle to be moved unless such

1 employee has obtained approval from a local law enforcement agency of  
2 a municipality, county, or city and county, the Colorado bureau of  
3 investigation, or the Colorado state patrol.

4 **SECTION 4.** In Colorado Revised Statutes, 13-21-113.7, **amend**  
5 (2)(a)(I) as follows:

6 **13-21-113.7. Immunity of volunteer firefighters, volunteers,**  
7 **incident management teams, and their employers or organizations -**  
8 **definitions - legislative declaration.**

9 (2) As used in this section:

10 (a) "Emergency" means any incident to which a response by a fire  
11 department or incident management team is appropriate or requested,  
12 including, without limitation:

13 (I) A fire, fire alarm response, motor vehicle ~~accident~~ CRASH,  
14 rescue call, or hazardous materials incident;

15 **SECTION 5.** In Colorado Revised Statutes, 13-21-115.5, **amend**  
16 (5) as follows:

17 **13-21-115.5. Volunteer service act - immunity - exception for**  
18 **operation of motor vehicles - exception for helicopter search and**  
19 **rescue - short title - legislative declaration - definitions.**

20 (5) Notwithstanding the provisions of subsection (4) of this  
21 section, a plaintiff may sue and recover civil damages from a volunteer  
22 based upon a negligent act or omission involving the operation of a motor  
23 vehicle during an activity; except that the amount recovered from such  
24 volunteer ~~shall~~ MUST not exceed the limits of applicable insurance  
25 coverage maintained by or on behalf of such volunteer with respect to the  
26 negligent operation of a motor vehicle in such circumstances. However,  
27 nothing in this section ~~shall be construed to limit~~ LIMITS the right of a

1 plaintiff to recover from a policy of uninsured or underinsured motorist  
2 coverage available to the plaintiff as a result of a motor vehicle ~~accident~~  
3 CRASH.

4 **SECTION 6.** In Colorado Revised Statutes, 13-80-102, **amend**  
5 (2) as follows:

6 **13-80-102. General limitation of actions - two years.**

7 (2) A civil action for a wrongful death against a defendant who  
8 committed vehicular homicide, as described in section 18-3-106, ~~C.R.S.~~,  
9 and, as part of the same criminal episode, committed the offense of  
10 leaving the scene of ~~an accident~~ A CRASH that resulted in the death of a  
11 person, as described in section 42-4-1601 (2)(c), ~~C.R.S.~~, regardless of the  
12 theory upon which suit is brought, or against whom suit is brought, must  
13 be commenced within four years after the cause of action accrues, and not  
14 thereafter.

15 **SECTION 7.** In Colorado Revised Statutes, 16-5-401, **amend**  
16 (1)(a) and (1)(a.5) as follows:

17 **16-5-401. Limitation for commencing criminal proceedings,**  
18 **civil infraction proceedings, and juvenile delinquency proceedings -**  
19 **definitions.**

20 (1) (a) Except as otherwise provided by statute applicable to  
21 specific offenses, delinquent acts, or circumstances, no adult person or  
22 juvenile shall be prosecuted, tried, or punished for any offense or  
23 delinquent act unless the indictment, information, complaint, or petition  
24 in delinquency is filed in a court of competent jurisdiction or a summons  
25 and complaint or penalty assessment notice is served upon the defendant  
26 or juvenile within the period of time after the commission of the offense  
27 or delinquent act as specified below:

1	Murder, kidnapping, treason, any sex offense	
2	against a child, and any forgery regardless of the	
3	penalty provided:	No limit
4	Attempt, conspiracy, or solicitation to commit

20 (a.5) The period of time during which an adult person or juvenile  
21 may be prosecuted for the offense of vehicular homicide, as described in  
22 section 18-3-106, ~~C.R.S.~~, and leaving the scene of ~~an accident~~ A CRASH  
23 that resulted in the death of a person, as described in section 42-4-1601  
24 (2)(c), ~~C.R.S.~~, when both offenses are alleged to have occurred as part of  
25 the same criminal episode in the same indictment, information, complaint,  
26 or petition in delinquency filed in a court of competent jurisdiction is ten  
27 years.

28 **SECTION 8.** In Colorado Revised Statutes, 18-3-106, **amend**

1 (4)(e) as follows:

2 **18-3-106. Vehicular homicide.**

3 (4) (e) Any person who is dead or unconscious ~~shall~~ MUST be  
4 tested to determine the alcohol or drug content of ~~his~~ THE PERSON'S blood  
5 or any drug content of ~~his~~ THE PERSON'S system as provided in this  
6 subsection (4). If a test cannot be administered to a person who is  
7 unconscious, hospitalized, or undergoing medical treatment because the  
8 test would endanger the person's life or health, the law enforcement  
9 agency ~~shall~~ MUST be allowed to test any blood, urine, or saliva which  
10 was obtained and not utilized by a health-care provider and ~~shall~~ MUST  
11 have access to that portion of the analysis and results of any tests  
12 administered by such provider which shows the alcohol or drug content  
13 of the person's blood or any drug content within ~~his~~ THE PERSON'S system.  
14 Such test results ~~shall~~ ARE not ~~be~~ considered privileged communications  
15 and the provisions of section 13-90-107 ~~C.R.S.~~, relating to the  
16 physician-patient privilege ~~shall~~ DO not apply. Any person who is dead,

22 **SECTION 9.** In Colorado Revised Statutes, 18-3-205, **amend**  
23 (4)(e) as follows:

24 **18-3-205. Vehicular assault.**

25 (4) (e) Any person who is dead or unconscious ~~shall~~ MUST be  
26 tested to determine the alcohol or drug content of ~~his~~ THE PERSON'S blood  
27 or any drug content of ~~his~~ THE PERSON'S system as provided in this

1 subsection (4). If a test cannot be administered to a person who is  
2 unconscious, hospitalized, or undergoing medical treatment because the  
3 test would endanger the person's life or health, the law enforcement  
4 agency ~~shall~~ MUST be allowed to test any blood, urine, or saliva which  
5 was obtained and not utilized by a health-care provider and ~~shall~~ MUST  
6 have access to that portion of the analysis and results of any tests  
7 administered by such provider which shows the alcohol or drug content  
8 of the person's blood or any drug content within ~~his~~ THE PERSON'S system.  
9 Such test results ~~shall~~ ARE not be considered privileged communications,

20 **pregnancy - definitions.**

21 (5) (e) Any person who is dead or unconscious ~~shall~~ MUST be  
22 tested to determine the alcohol or drug content of ~~his or her~~ THE PERSON'S  
23 blood or any drug content of ~~his or her~~ THE PERSON'S system as provided  
24 in this subsection (5). If a test cannot be administered to a person who is  
25 unconscious, hospitalized, or undergoing medical treatment because the  
26 test would endanger the person's life or health, the law enforcement  
27 agency ~~shall~~ MUST be allowed to test any blood, urine, or saliva that was

1 obtained and not utilized by a health-care provider and ~~shall~~ MUST have  
2 access to that portion of the analysis and results of any tests administered  
3 by the provider that show the alcohol or drug content of the person's  
4 blood or any drug content within ~~his or her~~ THE PERSON'S system. Such  
5 test results ~~shall~~ ARE not ~~be~~ considered privileged communications, and  
6 the provisions of section 13-90-107 ~~C.R.S.~~, relating to the  
7 physician-patient privilege ~~shall~~ DO not apply. Any person who is dead,  
8 in addition to the tests prescribed, ~~shall~~ MUST also have ~~his or her~~ THE  
9 PERSON'S blood checked for carbon monoxide content and for the  
10 presence of drugs, as prescribed by the department of public health and  
11 environment. Any information obtained ~~shall~~ MUST be made a part of the  
12 law enforcement officer's ~~accident~~ CRASH report.

13 **SECTION 11.** In Colorado Revised Statutes, 18-8-104, **amend**  
14 (1)(a) and (2.5)(a) as follows:

15 **18-8-104. Obstructing a peace officer, firefighter, emergency**  
16 **medical service provider, rescue specialist, or volunteer.**

17 (1) (a) A person commits obstructing a peace officer, firefighter,  
18 emergency medical service provider, rescue specialist, or volunteer when,  
19 by using or threatening to use violence, force, physical interference, or an  
20 obstacle, such person knowingly obstructs, impairs, or hinders the  
21 enforcement of the penal law or the preservation of the peace by a peace  
22 officer, acting under color of his or her official authority; knowingly  
23 obstructs, impairs, or hinders the prevention, control, or abatement of fire  
24 by a firefighter, acting under color of his or her official authority;  
25 knowingly obstructs, impairs, or hinders the administration of medical  
26 treatment or emergency assistance by an emergency medical service  
27 provider or rescue specialist, acting under color of his or her official

1 authority; or knowingly obstructs, impairs, or hinders the administration  
2 of emergency care or emergency assistance by a volunteer, acting in good  
3 faith to render such care or assistance without compensation at the place  
4 of an emergency or ~~accident~~ OR CRASH.

5 (2.5) If a person is alleged to have committed the offense  
6 described in subsection (1)(a) or (1)(b) of this section by using or  
7 threatening to use an unmanned aircraft system as an obstacle, the offense  
8 does not apply if the person who operates the unmanned aircraft system:

9 (a) Obtains permission to operate the unmanned aircraft system  
10 from a law enforcement agency or other entity that is coordinating the  
11 response of peace officers, firefighters, emergency medical service  
12 providers, rescue specialists, or volunteers to an emergency or ~~accident~~  
13 CRASH;

14 **SECTION 12.** In Colorado Revised Statutes, 24-4.1-102, **amend**  
15 (4)(a)(II) as follows:

16 **24-4.1-102. Definitions.**

17 As used in this part 1, unless the context otherwise requires:

18 (4) (a) "Compensable crime" means:

19 (II) An act in violation of section 42-4-1402 ~~C.R.S.~~, that results  
20 in the death or bodily injury of another person or section 42-4-1601,  
21 ~~C.R.S.~~, where the ~~accident~~ CRASH results in the death or bodily injury of  
22 another person.

23 **SECTION 13.** In Colorado Revised Statutes, 24-4.1-302, **amend**  
24 (1)(cc.6) as follows:

25 **24-4.1-302. Definitions.**

26 As used in this part 3, and for no other purpose, including the  
27 expansion of the rights of any defendant:

1 (1) "Crime" means any of the following offenses, acts, and  
2 violations as defined by the statutes of the state of Colorado, whether  
3 committed by an adult or a juvenile:

4 (cc.6) Failure to stop at the scene of ~~an accident~~ A CRASH, in  
5 violation of section 42-4-1601, where the ~~accident~~ CRASH results in the  
6 death or serious bodily injury of another person;

7 **SECTION 14.** In Colorado Revised Statutes, 24-33.5-203,  
8 **amend** (1)(b) as follows:

9 **24-33.5-203. Duties of executive director and patrol.**

10 (1) (b) Except as otherwise provided in section 40-10.1-108 (1),  
11 ~~€:R:S.~~, the executive director has the duty to establish, for motor carriers  
12 as defined in section 42-4-235, ~~€:R:S.~~, reasonable requirements to  
13 promote safety of operation and, to that end, to prescribe qualifications  
14 and maximum hours of service of employees and minimum standards of  
15 equipment and for the operation of commercial vehicles as defined in  
16 section 42-4-235. ~~€:R:S.~~ For the purpose of carrying out the provisions  
17 of this section pertaining to safety, the executive director may enlist the  
18 assistance of any agency of the United States or of this state having  
19 special knowledge of any matter as may be necessary to promote the  
20 safety of operation and equipment of motor vehicles as provided in this  
21 section. In adopting such rules, the executive director shall use as general  
22 guidelines the standards contained in the current rules of the United States  
23 department of transportation relating to explosives and other dangerous  
24 articles, safety regulations, qualifications of drivers, driving of motor  
25 vehicles, parts and accessories, recording and reporting of ~~accidents~~  
26 CRASHES, hours of service of drivers, and inspection and maintenance of  
27 motor vehicles. The state patrol shall enforce or aid in enforcing all of

1 such rules.

2 **SECTION 15.** In Colorado Revised Statutes, 24-33.5-212,  
3 **amend** (1)(e) as follows:

4 **24-33.5-212. Powers and duties of officers.**

5 (1) All officers of the Colorado state patrol have all the powers of  
6 any peace officer to:

7 (e) Investigate traffic ~~accidents~~ CRASHES and make reports thereof  
8 to the chief and make such reports to the department of transportation and  
9 department of revenue as these departments may require, but the reports  
10 required to be made to the chief in this ~~paragraph (e)~~ shall SUBSECTION  
11 (1)(e) ARE not be public records and ~~shall be~~ ARE for the confidential use  
12 of the Colorado state patrol;

13 **SECTION 16.** In Colorado Revised Statutes, 24-33.5-416.7,  
14 **amend** (1)(a), (1)(b), (2)(b), (3)(a), (3)(b) introductory portion, (3)(b)(I),  
15 (3)(c), (3)(e)(II), (4) introductory portion, and (4)(a) as follows:

16 **24-33.5-416.7. Medina alert program - legislative declaration**  
17 **- definitions - rules.**

18 (1) The general assembly hereby finds that:

19 (a) A person who kills or inflicts a serious bodily injury upon a  
20 person during a motor vehicle ~~accident~~ CRASH and flees the scene poses  
21 a serious and imminent threat to the safety of the public;

22 (b) When a person kills or inflicts a serious bodily injury upon a  
23 person during a motor vehicle ~~accident~~ CRASH and flees the scene, the  
24 first few hours after the act are critically important to apprehending the  
25 person; and

26 (2) As used in this section, unless the context otherwise requires:

27 (b) "Hit-and-run ~~accident~~ CRASH" means an incident when the

1 driver of a vehicle involved in ~~an accident~~ A CRASH fails to stop at the  
2 scene of the ~~accident~~ CRASH as required by section 42-4-1601. ~~C.R.S.~~

3 (3) (a) To facilitate the immediate apprehension of persons who  
4 kill or cause serious bodily injury to another person during a hit-and-run  
5 ~~accident~~ CRASH, there is created the Medina alert program to be  
6 implemented by the bureau on and after January 1, 2015. The program is  
7 a coordinated effort among the bureau, law enforcement agencies, and the  
8 state's public and commercial television and radio broadcasters.

9 (b) Using procedures established by rules ~~promulgated~~ ADOPTED  
10 pursuant to subsection (4) of this section, a law enforcement agency may  
11 notify the bureau after verifying that:

12 (I) A person has been killed or has suffered serious bodily injury  
13 during a hit-and-run ~~accident~~ CRASH; and

14 (c) Upon receipt of a notice from a law enforcement agency that  
15 a person has been killed or has suffered serious bodily injury during a  
16 hit-and-run ~~accident~~ CRASH and there is additional information  
17 concerning the suspect or the suspect's vehicle, the bureau, using  
18 procedures established by rules ~~promulgated~~ ADOPTED pursuant to  
19 subsection (4) of this section, shall confirm the accuracy of the  
20 information and issue a Medina alert.

21 (e) A Medina alert must include:

22 (II) A statement instructing anyone with information related to the  
23 hit-and-run ~~accident~~ CRASH to contact ~~his or her~~ THEIR local law  
24 enforcement agency; and

25 (4) On or before January 1, 2015, the executive director of the  
26 department of public safety shall ~~promulgate~~ ADOPT rules in accordance  
27 with the "State Administrative Procedure Act", article 4 of this ~~title~~ TITLE

1 24, for the implementation of the program. The rules ~~shall~~ MUST include  
2 but need not be limited to:

3 (a) Procedures for a law enforcement agency to use to notify the  
4 bureau that a person has been killed or has suffered serious bodily injury  
5 during a hit-and-run ~~accident~~ CRASH and there is additional information  
6 concerning the suspect or the suspect's vehicle;

7 **SECTION 17.** In Colorado Revised Statutes, 24-33.5-516,  
8 **amend** (2)(d) as follows:

9 **24-33.5-516. Study marijuana implementation.**

10 (2) To be included in the study, the division or contractor must  
11 have data for each of the two-year periods described in subsection (1) of  
12 this section. The study must include information concerning:

13 (d) Traffic ~~accidents~~ CRASHES, including fatalities and serious  
14 injuries related to being under the influence of marijuana;

15 **SECTION 18.** In Colorado Revised Statutes, 24-72-113, **amend**  
16 (2)(a) as follows:

17 **24-72-113. Limit on retention of passive surveillance records**  
18 **- definition.**

19 (2) (a) The custodian, as defined in section 24-72-202, may only  
20 access a passive surveillance record beyond the first anniversary after the  
21 date of the creation of the passive surveillance record, and up to the third  
22 anniversary after the date of the creation of the passive surveillance  
23 record, if there has been a notice of claim filed, or an accident, A CRASH,  
24 or other specific incident that may cause the passive surveillance record  
25 to become evidence in any civil, labor, administrative, or felony criminal  
26 proceeding, in which case the passive surveillance record may be  
27 retained. The custodian shall preserve a record of the reason for which the

1 passive surveillance record was accessed and the person who accessed the  
2 passive surveillance record beyond the first anniversary after its creation.  
3 All passive surveillance records must be destroyed after the third  
4 anniversary after the date of the creation of the passive surveillance  
5 record unless retention is authorized by this section.

6 **SECTION 19.** In Colorado Revised Statutes, 24-33.5-1505,  
7 **amend** (2)(b) as follows:

8 **24-33.5-1505. Immunity.**

9 (2) (b) Notwithstanding ~~paragraph (a) of this subsection (2)~~  
10 SUBSECTION (2)(a) OF THIS SECTION, a plaintiff may sue and recover civil  
11 damages from a person or entity specified in ~~said paragraph (a)~~  
12 SUBSECTION (2)(a) OF THIS SECTION based upon a negligent act or  
13 omission involving the operation of a motor vehicle; except that the  
14 amount recovered from such person or entity ~~shall~~ MUST not exceed the  
15 limits of applicable insurance coverage maintained by or on behalf of  
16 such person or entity with respect to the negligent operation of a motor  
17 vehicle in such circumstances. However, nothing in this section shall be  
18 construed to limit the right of a plaintiff to recover from a policy of

6 disclosure in clearly legible, written form: "This vehicle is not an  
7 electrical assisted bicycle as defined in state law pursuant to section  
8 42-1-102, Colorado Revised Statutes. It is instead a type of motor vehicle  
9 and subject to applicable motor vehicle laws if used on public roads or  
10 public lands. Your insurance policies may not provide coverage for  
11 ~~accidents~~ CRASHES involving the use of this vehicle. To determine  
12 coverage, you should contact your insurance company or agent."

4 (III) The data is released pursuant to a court order as part of an  
5 investigation of a suspected violation of a law that has caused, or  
6 contributed to the cause of, ~~an accident~~ A CRASH resulting in appreciable  
7 damage of property or injury to a person;

8 **SECTION 75.** In Colorado Revised Statutes, 42-7-102, **amend**  
9 (1), (2)(a) introductory portion, (2)(a)(I), and (2)(a)(III) as follows:

11 (1) The general assembly is acutely aware of the toll in human  
12 suffering and loss of life, limb, and property caused by negligence in the  
13 operation of motor vehicles in our state. Although it recognizes that this  
14 basic problem can be and is being dealt with by direct measures designed  
15 to protect our people from the ravages of irresponsible drivers, the  
16 general assembly is also very much concerned with the financial loss

2 (III) When innocent traffic ~~accident~~ CRASH victims cannot access  
3 either the negligent driver's automobile liability policy or their own  
4 uninsured motorist coverage, the burden of the uncompensated losses are  
5 borne by the taxpayer in the form of taxes for medicaid, by trauma  
6 facilities in the form of uncompensated hospital-related costs, and by the  
7 innocent victim.

1 TRANSPORTATION DEVICES.

2 (14) (a) "Proof of financial responsibility for the future", also  
3 referred to in this ~~article~~ ARTICLE 7 as proof of financial responsibility,  
4 means proof of ability to respond in damages for liability, on account of  
5 ~~accidents~~ CRASHES occurring after the effective date of said proof, arising  
6 out of the ownership, maintenance, or use of a motor vehicle, in the  
7 amount of twenty-five thousand dollars because of bodily injury to or  
8 death of one person in any one ~~accident~~ CRASH, and, subject to said limit  
9 for one person, in the amount of fifty thousand dollars because of bodily  
10 injury to or death of two or more persons in any one ~~accident~~ CRASH, and  
11 in the amount of fifteen thousand dollars because of injury to or  
12 destruction of property of others in any one ~~accident~~ CRASH.

13 **SECTION 77.** In Colorado Revised Statutes, 42-7-301, **amend**

3 acquired or held by a law enforcement agency in the course of motor  
4 vehicle law enforcement or related highway duties and under  
5 circumstances supporting a reasonable belief that such property was

4 **SECTION 96. Act subject to petition - effective date.**

5 (1) Except as otherwise provided in this section, this act takes  
6 effect at 12:01 a.m. on the day following the expiration of the ninety-day  
7 period after final adjournment of the general assembly (August 12, 2026,  
8 if adjournment sine die is on May 13, 2026); except that, if a referendum  
9 petition is filed pursuant to section 1 (3) of article V of the state  
10 constitution against this act or an item, section, or part of this act within  
11 such period, then the act, item, section, or part will not take effect unless  
12 approved by the people at the general election to be held in November  
13 2026 and, in such case, will take effect on the date of the official  
14 declaration of the vote thereon by the governor.

15 (2) Section 67 of this act takes effect only if House Bill 26-1127  
16 does not become law, in which case section 67 takes effect on the
