A BILL FOR AN ACT

101 **CONCERNING MODIFICATIONS TO ENVIRONMENTAL STANDARDS FOR**
102 **CERTAIN IRRIGATION EQUIPMENT.**

Bill Summary

House Bill 23-1161 established environmental standards for irrigation controllers and spray sprinkler bodies that are sold or leased in the state on and after January 1, 2026, and are not specifically excluded from the federal WaterSense program (program).

The bill repeals the environmental standard for irrigation controllers. The bill also modifies the environmental standard for spray

sprinkler bodies to:

- No longer require that spray sprinkler bodies include a check valve; and
- Require that spray sprinkler bodies are certified to the program, rather than requiring that spray sprinkler bodies meet the water efficiency and performance criteria of the program.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 6-7.5-102, **repeal**
3 (10), (38), (47), and (62) as follows:

4 **6-7.5-102. Definitions.**

5 As used in this article 7.5, unless the context otherwise requires
6 and except as determined by rule pursuant to section 6-7.5-106 (1):

7 ~~(10) "Check valve" means a component that is internal to a spray~~
8 ~~sprinkler body and prevents system drainage during periods of~~
9 ~~nonoperation.~~

11 ~~(38) "Irrigation controller" means a standalone controller, an~~
12 ~~add-on device, or a plug-in device that is used to operate an automatic~~
13 ~~irrigation system such as a lawn sprinkler or drip irrigation system~~
14 ~~designed and intended for nonagricultural purposes. "Irrigation~~
15 ~~controller" includes:~~

16 ~~(a) A soil moisture-based irrigation controller that inhibits or~~
17 ~~allows an irrigation event based on a reading from a soil moisture sensor~~
18 ~~mechanism; and~~

19 ~~(b) A weather-based irrigation controller that uses current weather~~
20 ~~data as a basis for scheduling irrigation.~~

21 ~~(47) "Pressure regulator" means a device that maintains constant~~
22 ~~operating pressure immediately downstream from a spray sprinkler body.~~

2 (62) "Spray sprinkler body" means the exterior case or shell of a
3 sprinkler designed and intended for nonagricultural uses, which case or
4 shell:

5 (a) Incorporates a means of connection to the piping system; and

6 (b) Is designed to convey water to a nozzle or orifice.

7 **SECTION 2.** In Colorado Revised Statutes, 6-7.5-104, **repeal**
8 (1)(j.7) and (1)(n) as follows:

9 **6-7.5-104. Scope and applicability.**

10 (1) Subject to subsection (2) of this section and as further
11 specified in section 6-7.5-105, this article 7.5 applies to the following
12 products sold as new in Colorado:

13 (j.7) ~~Irrigation controllers;~~

14 (n) Spray sprinkler bodies;

15 **SECTION 3.** In Colorado Revised Statutes, 6-7.5-105, **repeal**
16 (5)(h) and (5)(k) as follows:

17 **6-7.5-105. Standards - effective dates.**

18 (5) On and after January 1, 2026, a person shall not sell, offer to
19 sell, lease, or offer to lease any of the following new products in Colorado
20 unless the efficiency of the new product meets or exceeds the following
21 efficiency standards, as applicable:

22 (h) ~~Irrigation controllers must comply with the following~~
23 ~~requirements:~~

24 ~~(I) Weather-based irrigation controllers included within the scope~~
25 ~~of the WaterSense program product specification for weather-based~~
26 ~~irrigation controllers must meet the water efficiency and performance~~
27 ~~criteria and other requirements for that specification; and~~

1 ~~(H) Soil moisture-based irrigation controllers included within the~~
2 ~~scope of the WaterSense program product specification for soil~~

5 ~~(k) Spray sprinkler bodies that are not specifically excluded from~~
6 ~~the scope of the WaterSense program product specification for spray~~
7 ~~sprinkler bodies must include an integral pressure regulator and a check~~
8 ~~valve and must meet the water efficiency and performance criteria and~~
9 ~~other requirements of that specification.~~

11 **SECTION 4. Act subject to petition - effective date -**
12 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
13 the expiration of the ninety-day period after final adjournment of the
14 general assembly (August 12, 2026, if adjournment sine die is on May 13,
15 2026); except that, if a referendum petition is filed pursuant to section 1
16 (3) of article V of the state constitution against this act or an item, section,
17 or part of this act within such period, then the act, item, section, or part
18 will not take effect unless approved by the people at the general election
19 to be held in November 2026 and, in such case, will take effect on the
20 date of the official declaration of the vote thereon by the governor.

21 (2) This act applies to conduct occurring on or after the applicable
22 effective date of this act.
