monument preservation trust fund (trust fund). The bill moves oversight of the trust fund to the state historical society (history Colorado) and repeals the preservation trust committee. The bill also expands the allowable uses of the trust fund, which were previously restricted to maintaining and enhancing the Colorado veterans' monument and any fallen heroes memorials in Lincoln veterans' memorial park, to include the maintenance, enhancement, and repair of monuments and memorials both in Lincoln veterans' memorial park and on the state capitol building grounds. History Colorado may expend principal from the trust fund for these purposes once every 20 years beginning in state fiscal year 2027-2028, subject to appropriation by the general assembly, and for unexpected necessary maintenance costs that are not covered by insurance. On or before December 31, 2026, and on or before each December 31 thereafter, history Colorado must submit a report to the state capitol building advisory committee that includes information on:

- History Colorado's plans to maintain, enhance, and repair monuments and memorials in Lincoln veterans' memorial park and on the state capitol building grounds; and
- The actual and planned use of money in the trust fund.

The bill also requires the state capitol building advisory committee, before recommending a proposal for the placement of a memorial or an object of art on the state capitol building grounds to the capital development committee and the governor for approval, to ensure that the proposal includes funding sufficient to provide lifetime maintenance of the proposed memorial or object of art. Only a proposal that dedicates at least 5% of its total budget to maintenance includes funding sufficient to provide lifetime maintenance of the proposed object of art or memorial.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-80-1401, **amend**
3 (1), (4), and (5); **repeal** (2) and (3); and **add** (5.5) as follows:

4 **24-80-1401. Colorado veterans' monument preservation trust**
5 **fund - state historical society - park name change - report.**

6 (1) There is hereby created in the state treasury the Colorado
7 veterans' monument preservation trust fund, referred to in this section as
8 the "trust fund", the principal of which ~~shall consist~~ CONSISTS of funds
9 MONEY made available from ~~private~~ GIFTS, GRANTS, AND donations

1 received by the ~~department of personnel~~ STATE HISTORICAL SOCIETY,
2 MONEY CREDITED TO THE TRUST FUND AS SPECIFIED IN SUBSECTION (4)(e)
3 OF THIS SECTION, and any ~~funds appropriated thereto~~ MONEY
4 TRANSFERRED TO THE TRUST FUND by the general assembly. All ~~moneys~~

16 ~~member shall be a representative or designee of the Colorado board of~~
17 ~~veterans affairs, created in section 28-5-702, one member shall be a~~
18 ~~member or designee of the state capitol building advisory committee,~~
19 ~~created in section 24-82-108, one member shall be a veteran appointed~~
20 ~~jointly by the speaker of the house of representatives and the president of~~

1 ~~(b) of this subsection (3), the member appointed by the speaker of the~~

3 ~~two-year term. Any vacancy on the committee shall be filled in the same~~

6 (b) ~~The term of the member appointed by the speaker of the house~~

22 (c) SUBJECT TO APPROPRIATION BY THE GENERAL ASSEMBLY, THE
23 STATE HISTORICAL SOCIETY MAY EXPEND PRINCIPAL FROM THE TRUST
24 FUND FOR THE PURPOSES SET FORTH IN SUBSECTION (4)(a) OF THIS SECTION
25 IN STATE FISCAL YEAR 2027-2028 AND ONCE EVERY TWENTY STATE FISCAL
26 YEARS THEREAFTER.

27 (d) THE STATE HISTORICAL SOCIETY MAY EXPEND PRINCIPAL FROM

1 THE TRUST FUND FOR UNEXPECTED MAINTENANCE THAT IS NOT COVERED
2 BY INSURANCE, AS LONG AS THE MAINTENANCE IS NECESSARY AND
3 SUFFICIENT PRINCIPAL EXISTS IN THE TRUST FUND.

4 (e) MONEY GIFTED, GRANTED, DONATED, OR OTHERWISE CREDITED
5 TO THE TRUST FUND IN CONNECTION WITH THE PLACEMENT OF AN
6 APPROVED OBJECT OF ART OR MEMORIAL ON THE GROUNDS SURROUNDING
7 THE STATE CAPITOL BUILDING, AS DESCRIBED IN SECTION 24-82-108
8 (3)(h)(IV), IS CONTINUOUSLY APPROPRIATED TO THE STATE HISTORICAL
9 SOCIETY FOR THE LIFETIME MAINTENANCE OF THE OBJECT OF ART OR

11 (f) DONATIONS MADE IN CONNECTION WITH A PERMIT TO USE THE
12 LINCOLN VETERANS' MEMORIAL PARK ARE CONTINUOUSLY APPROPRIATED
13 TO THE STATE HISTORICAL SOCIETY FOR MAINTAINING AND RESTORING
14 MONUMENTS AND MEMORIALS IN LINCOLN VETERANS' MEMORIAL PARK.

15 (5) ~~The department of personnel~~ STATE HISTORICAL SOCIETY is
16 authorized to receive gifts, grants, and donations from private or public
17 sources for the trust fund. ~~Such~~ THE gifts, grants, and donations ~~together~~
18 ~~with any other money appropriated or transferred by the general~~
19 ~~assembly, shall~~ MUST be transmitted to the state treasurer, who shall credit
20 the same to the trust fund. ~~Money in the trust fund shall be used for~~
21 ~~maintaining and enhancing the Colorado veterans' monument and Lincoln~~
22 ~~veterans' memorial park, but shall not be used to supplant existing~~
23 ~~appropriations for maintenance of the monument or Lincoln veterans'~~

25 THIS SECTION, ALL GIFTS, GRANTS, AND DONATIONS RECEIVED BY THE

3 (5.5) ON OR BEFORE DECEMBER 31, 2026, AND ON OR BEFORE
4 EACH DECEMBER 31 THEREAFTER, THE STATE HISTORICAL SOCIETY SHALL
5 SUBMIT A REPORT TO THE STATE CAPITOL BUILDING ADVISORY COMMITTEE
6 CREATED IN SECTION 24-82-108. THE REPORT MUST INCLUDE
7 INFORMATION ON:

8 (a) THE STATE HISTORICAL SOCIETY'S PLANS TO MAINTAIN,
9 ENHANCE, AND REPAIR MONUMENTS AND MEMORIALS IN LINCOLN
10 VETERANS' MEMORIAL PARK AND ON THE GROUNDS SURROUNDING THE
11 STATE CAPITOL BUILDING; AND

12 (b) THE ACTUAL AND PLANNED USE OF MONEY IN THE TRUST FUND.

13 **SECTION 2.** In Colorado Revised Statutes, 24-82-108, **add**
14 (3)(h)(IV) as follows:

15 **24-82-108. State capitol building advisory committee -**
16 **creation - duties - legislative declaration - repeal.**

17 (3) **Duties of the advisory committee.** The advisory committee
18 has the duties specified in subsections (3)(a) to (3)(i) of this section.

19 (h) **Proposals for a gift or loan of art and memorials.**

20 (IV) BEFORE RECOMMENDING A PROPOSAL FOR THE PLACEMENT
21 OF AN OBJECT OF ART OR MEMORIAL ON THE SURROUNDING GROUNDS OF
22 THE CAPITOL TO THE CAPITAL DEVELOPMENT COMMITTEE AND THE
23 GOVERNOR FOR APPROVAL, THE ADVISORY COMMITTEE SHALL ENSURE
24 THAT THE PROPOSAL INCLUDES FUNDING SUFFICIENT TO PROVIDE LIFETIME
25 MAINTENANCE OF THE PROPOSED OBJECT OF ART OR MEMORIAL. ONLY A
26 PROPOSAL THAT DEDICATES AT LEAST FIVE PERCENT OF ITS TOTAL BUDGET
27 TO MAINTENANCE INCLUDES FUNDING SUFFICIENT TO PROVIDE LIFETIME

1 MAINTENANCE OF THE PROPOSED OBJECT OF ART OR MEMORIAL. AFTER
2 THE CAPITAL DEVELOPMENT COMMITTEE AND THE GOVERNOR APPROVE A
3 PROPOSAL FOR THE PLACEMENT OF AN OBJECT OF ART OR MEMORIAL ON
4 THE SURROUNDING GROUNDS OF THE CAPITOL IN ACCORDANCE WITH
5 SUBSECTION (3)(h)(I)(B) OF THIS SECTION, THE MONEY IDENTIFIED IN THE
6 PROPOSAL FOR THE LIFETIME MAINTENANCE OF THE PROPOSED OBJECT OF
7 ART OR MEMORIAL MUST BE GIFTED, GRANTED, DONATED, OR OTHERWISE
8 CREDITED TO THE COLORADO VETERANS' MONUMENT PRESERVATION
9 TRUST FUND CREATED IN SECTION 24-80-1401.

10 SECTION 3. Safety clause. The general assembly finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, or safety or for appropriations for
13 the support and maintenance of the departments of the state and state
14 institutions.
