101      **CONCERNING A TECHNICAL REVISION TO LANGUAGE IN SENATE BILL**  
102            **25-070 RELATED TO A REQUIREMENT FOR ONLINE**  
103            **MARKETPLACES WITH RESPECT TO THIRD-PARTY SELLERS.**

**Bill Summary**

**Statutory Revision Committee.** The bill makes a technical revision to language from Senate Bill 25-070, enacted in 2025, to clarify an online marketplace's obligation to alert law enforcement if the online marketplace knows or should have known that a third-party seller is selling or attempting to sell stolen goods to a consumer in Colorado.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 6-1-1402, **amend**  
3 (5)(b) introductory portion as follows:

4           **6-1-1402. Disclosure of information by online marketplaces to**  
5 **inform consumers - reporting of suspicious marketplace activity.**

6           **(5) Reporting mechanism.**

7           (b) An online marketplace shall alert a law enforcement agency  
8 if the online marketplace knows or should have known that a third-party  
9 seller is selling or attempting to sell stolen goods to a consumer in  
10 Colorado, unless the online marketplace has received a notice from the  
11 law enforcement agency that the same third-party seller is suspected OF  
12 SELLING or attempting to sell the same stolen goods on the online  
13 marketplace to a consumer in Colorado. An online marketplace shall  
14 establish:

15           **SECTION 2. Act subject to petition - effective date.** This act  
16 takes effect at 12:01 a.m. on the day following the expiration of the  
17 ninety-day period after final adjournment of the general assembly (August  
18 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a  
19 referendum petition is filed pursuant to section 1 (3) of article V of the  
20 state constitution against this act or an item, section, or part of this act  
21 within such period, then the act, item, section, or part will not take effect  
22 unless approved by the people at the general election to be held in  
23 November 2026 and, in such case, will take effect on the date of the  
24 official declaration of the vote thereon by the governor.
