**Committee.** The bill implements the recommendation of the Colorado office of policy, research, and regulatory reform in the department of regulatory agencies in its sunset review and report by continuing the regulation of hemodialysis clinics and technicians for 11 years, until September 1, 2037.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **amend**  
3 (27)(a)(XV); and **add** (38)(a)(II) as follows:

4           **24-34-104. General assembly review of regulatory agencies**  
5 **and functions for repeal, continuation, or reestablishment - legislative**  
6 **declaration - repeal.**

7           (27) (a) The following agencies, functions, or both, are scheduled  
8 for repeal on September 1, 2026:

9           (XV) ~~The regulation of dialysis treatment clinics and hemodialysis~~  
10 ~~technicians in accordance with section 25-1.5-108;~~

11           (38) (a) The following agencies, functions, or both, are scheduled  
12 for repeal on September 1, 2037:

13           (II) THE REGULATION OF DIALYSIS TREATMENT CLINICS AND  
14 HEMODIALYSIS TECHNICIANS IN ACCORDANCE WITH SECTION 25-1.5-108.

15           **SECTION 2.** In Colorado Revised Statutes, 25-1.5-108, **amend**  
16 (6) as follows:

17           **25-1.5-108. Regulation of dialysis treatment clinics - training**  
18 **for hemodialysis technicians - state board of health rules - definitions**  
19 **- repeal.**

20           (6) This section is repealed, effective ~~September 1, 2026~~  
21 SEPTEMBER 1, 2037. Before the repeal, this section is scheduled for  
22 review in accordance with section 24-34-104.

23           **SECTION 3. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the  
2 ninety-day period after final adjournment of the general assembly (August  
3 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a  
4 referendum petition is filed pursuant to section 1 (3) of article V of the  
5 state constitution against this act or an item, section, or part of this act  
6 within such period, then the act, item, section, or part will not take effect  
7 unless approved by the people at the general election to be held in  
8 November 2026 and, in such case, will take effect on the date of the  
9 official declaration of the vote thereon by the governor.
