A BILL FOR AN ACT

101 **CONCERNING THE CONTINUATION OF THE COLORADO PODIATRY**
102 **BOARD, AND, IN CONNECTION THEREWITH, IMPLEMENTING THE**
103 **RECOMMENDATION IN THE 2025 SUNSET REPORT BY THE**
104 **DEPARTMENT OF REGULATORY AGENCIES TO REQUIRE**

Committee. The bill implements recommendations of the department of regulatory agencies in its 2025 sunset review and report on the Colorado podiatry board.

Sections 1 and 3 of the bill extend the repeal of the functions of licensing and regulating podiatrists to September 1, 2035.

Section 2 requires licensed podiatrists to develop a written plan to ensure the security of patient medical records.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-290-105, **amend**
3 (4) as follows:

4 **12-290-105. Appointment of members of podiatry board -**
5 **terms - review of functions - repeal of article.**

6 (4) This article 290 is repealed, effective September 1, ~~2026~~ 2035.
7 Before the repeal, the functions of the board are scheduled for review in
8 accordance with section 24-34-104.

9 **SECTION 2.** In Colorado Revised Statutes, **add** 12-290-125 as
10 follows:

11 **12-290-125. Protection of medical records by podiatrists -**
12 **verification of compliance - noncompliance grounds for discipline -**
13 **rules.**

14 (1) EACH LICENSED PODIATRIST SHALL DEVELOP A WRITTEN PLAN
15 TO ENSURE THE SECURITY OF PATIENT MEDICAL RECORDS. THE PLAN MUST
16 ADDRESS AT LEAST THE FOLLOWING:

17 (a) THE STORAGE AND PROPER DISPOSAL, IF APPROPRIATE, OF
18 PATIENT MEDICAL RECORDS;

19 (b) THE DISPOSITION OF PATIENT MEDICAL RECORDS IN THE EVENT
20 THE LICENSEE DIES, RETIRES, OR OTHERWISE CEASES TO PRACTICE OR
21 PROVIDE MEDICAL CARE TO PATIENTS; AND

22 (c) THE METHOD BY WHICH A PATIENT MAY ACCESS OR OBTAIN THE

1 PATIENT'S MEDICAL RECORDS PROMPTLY IF ANY OF THE EVENTS
2 DESCRIBED IN SUBSECTION (1)(b) OF THIS SECTION OCCUR.

3 (2) UPON INITIAL LICENSURE UNDER THIS ARTICLE 290 AND UPON
4 RENEWAL OF A LICENSE, AN APPLICANT OR LICENSEE, AS APPLICABLE,
5 SHALL ATTEST TO THE BOARD THAT THE APPLICANT OR LICENSEE HAS
6 DEVELOPED A PLAN IN COMPLIANCE WITH THIS SECTION.

7 (3) A LICENSEE SHALL INFORM EACH PATIENT, IN WRITING, OF THE
8 METHOD BY WHICH THE PATIENT MAY ACCESS OR OBTAIN THE PATIENT'S
9 MEDICAL RECORDS IF AN EVENT DESCRIBED IN SUBSECTION (1)(b) OF THIS
10 SECTION OCCURS.

11 (4) A LICENSEE WHO FAILS TO COMPLY WITH THIS SECTION IS
12 SUBJECT TO DISCIPLINE IN ACCORDANCE WITH SECTION 12-290-113.

13 (5) THE BOARD MAY ADOPT RULES AS NECESSARY TO IMPLEMENT
14 THIS SECTION.

15 **SECTION 3.** In Colorado Revised Statutes, 24-34-104, **repeal**
16 (27)(a)(VIII); and **add** (36)(a)(VII) as follows:

17 **24-34-104. General assembly review of regulatory agencies**
18 **and functions for repeal, continuation, or reestablishment - legislative**
19 **declaration - repeal.**

20 (27) (a) The following agencies, functions, or both, are scheduled
21 for repeal on September 1, 2026:

22 (VIII) ~~The Colorado podiatry board created in article 290 of title~~

24 (36) (a) The following agencies, functions, or both, are scheduled
25 for repeal on September 1, 2035:

26 (VII) THE COLORADO PODIATRY BOARD CREATED IN ARTICLE 290
27 OF TITLE 12.

1 **SECTION 4. Act subject to petition - effective date.** This act
2 takes effect at 12:01 a.m. on the day following the expiration of the
3 ninety-day period after final adjournment of the general assembly (August
4 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
5 referendum petition is filed pursuant to section 1 (3) of article V of the
6 state constitution against this act or an item, section, or part of this act
7 within such period, then the act, item, section, or part will not take effect
8 unless approved by the people at the general election to be held in
9 November 2026 and, in such case, will take effect on the date of the
10 official declaration of the vote thereon by the governor.
