**Bill Summary**

For state fiscal year 2026-27, the bill appropriates \$5,000,000 from the species conservation trust fund in the state treasury for various wildlife conservation programs directed at conserving candidate species or species that are likely to become candidate species, as determined by the United States fish and wildlife service. Colorado department of natural resources, after consulting with the Colorado water conservation board, the parks and wildlife commission, and the director of the division of parks and wildlife, has submitted to the general assembly a list of programs and associated costs that are eligible to receive funding from the species conservation trust fund as follows:

- \$2,380,000 for the upper Colorado river endangered fish recovery program and San Juan river basin recovery implementation program;
- \$60,000 for Rio Grande native fish protection and habitat improvements;
- \$60,000 for selenium management, research, monitoring, evaluation, and control;
- \$1,250,000 for native terrestrial wildlife conservation; and
- \$1,250,000 for native aquatic wildlife conservation.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 finds and declares that:

4 (a) Section 24-33-111 (2), Colorado Revised Statutes, creates the  
5 species conservation trust fund in the state treasury to fund programs  
6 designed to conserve native species that have been listed as threatened or  
7 endangered under state or federal law or that are candidate species or are  
8 likely to become candidate species, as determined by the United States  
9 fish and wildlife service; and

10 (b) Pursuant to section 24-33-111 (3), Colorado Revised Statutes:

11 (I) The executive director of the department of natural resources,  
12 after consulting with the Colorado water conservation board, the parks  
13 and wildlife commission, and the director of the division of parks and  
14 wildlife, has prepared and delivered to the general assembly a species  
15 conservation eligibility list describing programs and associated costs that  
16 are eligible to receive funding from the species conservation trust fund;  
17 and

1 (II) The species conservation eligibility list is subject to  
2 modification and adoption through the passage of this Senate Bill 26-\_\_\_\_,  
3 enacted in 2026.

4 **SECTION 2. Eligibility list - approval.** (1) The general  
5 assembly deems the recommended expenditures described in the species  
6 conservation eligibility list to be in the interest of the people of the state.  
7 The money specified in this subsection (1) is available in state fiscal year  
8 2026-27 and remains available for the designated purposes until it is fully  
9 expended. The executive director of the department of natural resources  
10 is authorized to obligate and expend five million dollars (\$5,000,000)  
11 from the species conservation trust fund created in section 24-33-111 (2),  
12 Colorado Revised Statutes, for the following activities, programs, and  
13 species in the following amounts:
