The bill renames the Colorado youth advisory council review committee to honor and memorialize Senator Faith Winter.

1 **SECTION 1.** In Colorado Revised Statutes, 2-2-1305.5, **amend**
2 (1) as follows:

3 **2-2-1305.5. Representative Hugh McKean and Senator Faith**
4 **Winter Colorado youth advisory council review committee - created.**

5 (1) There is created in the legislative branch the Representative
6 Hugh McKean AND SENATOR FAITH WINTER Colorado youth advisory
7 council review committee to review the council's work. The committee
8 is comprised of ten members, as described in subsection (2) of this
9 section.

10 **SECTION 2.** In Colorado Revised Statutes, 2-2-1301.5, **amend**
11 (4) as follows:

12 **2-2-1301.5. Definitions.**

13 As used in this part 13, unless the context otherwise requires:

14 (4) "Review committee" means the Representative Hugh McKean
15 AND SENATOR FAITH WINTER Colorado youth advisory council review
16 committee created in section 2-2-1305.5.

17 **SECTION 3. Act subject to petition - effective date.** This act
18 takes effect at 12:01 a.m. on the day following the expiration of the
19 ninety-day period after final adjournment of the general assembly (August
20 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
21 referendum petition is filed pursuant to section 1 (3) of article V of the
22 state constitution against this act or an item, section, or part of this act
23 within such period, then the act, item, section, or part will not take effect
24 unless approved by the people at the general election to be held in
25 November 2026 and, in such case, will take effect on the date of the
26 official declaration of the vote thereon by the governor.
