101      **CONCERNING HIGHER EDUCATION FUNDING, AND, IN CONNECTION**  
102              **THEREWITH, IMPLEMENTING THE RECOMMENDATIONS IN THE**

**Bill Summary**

The bill changes the higher education funding provisions, effective for the 2027-28 state fiscal year.

Under current law, a state institution of higher education's

governing board's annual fee-for-service contract includes funding calculated based on 3 components: Ongoing additional funding, performance funding, and temporary additional funding. The bill:

- Changes the name of the funding from "performance funding" to "results-informed funding";
- Redefines some of the terms and metrics that are used to determine results-informed funding; and
- Reorders the components and eliminates current statutory language that requires sequential calculation of the components.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 23-18-302, **amend**  
3 (4)(b), (8), (9), (10), (14), and (17); **repeal** (18); and **add** (2.5), (11.5),  
4 and (21.5) as follows:

5           **23-18-302. Definitions - repeal.**

6           As used in this part 3, unless the context otherwise requires:

7           (2.5)(a) "CO-LOCATED DEGREE PARTNERSHIP" MEANS A PROGRAM  
8 FORMALIZED BY A WRITTEN AGREEMENT BETWEEN TWO INSTITUTIONS IN  
9 WHICH:

10           (I) A STUDENT IS ENROLLED AS A DEGREE-SEEKING STUDENT AT  
11 THEIR HOME INSTITUTION IN A DEGREE PROGRAM THAT IS NOT OFFERED TO  
12 COMPLETION AT THEIR HOME INSTITUTION;

13           (II) THE STUDENT SUBSEQUENTLY MATRICULATES AS A TRANSFER  
14 AND DEGREE-SEEKING STUDENT AT A PARTNER INSTITUTION THAT OFFERS  
15 THE DEGREE PROGRAM TO COMPLETION THAT THE STUDENT'S HOME  
16 INSTITUTION DOES NOT OFFER TO COMPLETION; AND

17           (III) FOR A PERIOD OF TIME, AS DEFINED BY THE AGREEMENT  
18 BETWEEN THE TWO INSTITUTIONS, THE STUDENT CONTINUES TO PRIMARILY  
19 BE LOCATED AT THE HOME INSTITUTION'S CAMPUS, INCLUDING RECEIVING  
20 INSTRUCTION, ACADEMIC SERVICES, LIBRARY ACCESS, OR STUDENT

5 MULTILATERAL TRANSFER AGREEMENT;

6 (II) GENERAL TRANSFER PARTNERSHIPS;

7 (III) CROSS-REGISTRATION OR COURSE-SHARING PARTNERSHIPS,  
8 INCLUDING ONLINE-ONLY COURSE ARRANGEMENTS;

9 (IV) CONCURRENT OR DUAL ENROLLMENT WITHOUT A  
10 CO-LOCATION DELIVERY COMPONENT; OR

11 (V) ANY PROGRAM IN A DEGREE PROGRAM THAT IS OFFERED TO  
12 COMPLETION AT THE STUDENT'S HOME INSTITUTION.

13 (c) THE DEPARTMENT SHALL ENSURE THAT THE GOVERNING  
14 BOARDS COLLECT AND REPORT THE DATA IN A CONSISTENT MANNER.

15 (4) "Credential completion" means the calculation of student  
16 credential completion by a governing board based on equal weighting of  
17 the total resident student completions of postsecondary credentials in a  
18 given state fiscal year. The credential completion calculation includes:

19 (b) Equal weighting for a resident student who transfers out of an  
20 institution ~~with a community college role and mission specified in statute,~~  
21 after accumulating at least eighteen credit hours at the institution ~~in a~~  
22 ~~two-year degree program~~ AND TRANSFERRING WITHIN THE NEXT  
23 ACADEMIC YEAR INTO ANOTHER INSTITUTION, AREA TECHNICAL COLLEGE,  
24 OR LOCAL DISTRICT COLLEGE.

25 (8) "One-hundred-fifty-percent-of-time graduation rate" means,  
26 for a four-year institution, the percentage of first-time, full-time,  
27 degree-seeking undergraduate students starting in the fall term and

1 graduating within six years with a bachelor's degree from the same  
2 institution, and, for a two-year institution, the percentage of first-time,  
3 full-time, associate degree-seeking or undergraduate certificate-seeking  
4 students starting in the fall term and completing their declared program  
5 within one hundred fifty percent of the normal time to completion, as  
6 reported to the ~~integrated postsecondary education data system~~  
7 ~~maintained by the federal department of education.~~ If the ~~integrated~~

9 institution or governing board for prior state fiscal years, the department

24 institution, and, for a two-year institution, the percentage of first-time,  
25 full-time, associate degree-seeking or undergraduate certificate-seeking  
26 students starting in the fall term and completing their declared program  
27 within one hundred percent of the normal time to completion, as reported

1 to the ~~integrated postsecondary education data system maintained by the~~  
2 ~~federal department of education. If the integrated postsecondary~~  
3 ~~education data system does not include data for an institution or~~  
4 ~~governing board for prior state fiscal years, the department shall use its~~  
5 ~~available data, as reported by the governing board to the department~~  
6 ~~through the student-unit record database, in place of the missing~~

20 TO SECTIONS 23-18-202 AND 23-18-303.5, EXCLUDING THE AMOUNT

6 degree-seeking or undergraduate certificate-seeking students starting in  
7 the fall term and either returning for or successfully completing their  
8 declared program by the second fall term at the same institution, as  
9 reported to the ~~integrated postsecondary education data system~~  
10 ~~maintained by the federal department of education. If the integrated~~

2 **SECTION 2.** In Colorado Revised Statutes, 23-18-303.5, **amend**  
3 (1)(a), (2) introductory portion, (2)(a), (3), and (7); **repeal** (4), (5), and  
4 (8); and **add** (1.3) and (1.5) as follows:

5 **23-18-303.5. Fee-for-service contracts - authorization -**  
6 **results-informed funding.**

7 (1) (a) For the ~~2021-22~~ 2027-28 state fiscal year and each state  
8 fiscal year thereafter, the governing board of a state institution of higher  
9 education may annually negotiate a fee-for-service contract with the  
10 department pursuant to this section for the delivery of higher education  
11 services by the institution for the benefit of the state and its residents.  
12 Specialty education programs, area technical colleges, and local district  
13 colleges are funded pursuant to the provisions of section 23-18-304.

14 (1.3) **Results-informed funding metrics.**

15 (a) THE COMMISSION, IN CONJUNCTION WITH THE DEPARTMENT  
16 AND IN COLLABORATION WITH THE GOVERNING BOARDS, SHALL  
17 CALCULATE RESULTS-INFORMED FUNDING FOR EACH GOVERNING BOARD  
18 BASED ON THE RATE OF CHANGE OVER TIME IN THE PERFORMANCE OF THE  
19 INSTITUTIONS OVERSEEN BY THE GOVERNING BOARD ON THE  
20 RESULTS-INFORMED FUNDING METRICS SPECIFIED IN SUBSECTION (1.3)(b)  
21 OF THIS SECTION. THE RECOMMENDATION FOR RESULTS-INFORMED  
22 FUNDING MAY REFLECT A CHANGE IN THE TOTAL STATE APPROPRIATION,

11 (c) (I) IN PREPARING ANNUAL BUDGET RECOMMENDATIONS, THE  
12 COMMISSION, IN CONJUNCTION WITH THE DEPARTMENT AND IN  
13 COLLABORATION WITH THE GOVERNING BOARDS, MAY ANNUALLY  
14 IDENTIFY THE PORTION OF TOTAL RESULTS-INFORMED FUNDING THAT IS  
15 ALLOCATED TO EACH RESULTS-INFORMED FUNDING METRIC SPECIFIED IN  
16 SUBSECTION (1.3)(b) OF THIS SECTION.

17 (II) THE JOINT BUDGET COMMITTEE, AFTER CONSIDERING THE  
18 COMMISSION'S ANNUAL BUDGET RECOMMENDATIONS, SHALL DETERMINE  
19 THE PORTION OF TOTAL RESULTS-INFORMED FUNDING FOR THE APPLICABLE  
20 STATE FISCAL YEAR THAT IS ALLOCATED TO EACH RESULTS-INFORMED  
21 FUNDING METRIC SPECIFIED IN SUBSECTION (1.3)(b) OF THIS SECTION.

26 (a) THE AMOUNT OF RESULTS-INFORMED FUNDING THAT A  
27 GOVERNING BOARD RECEIVES FOR EACH RESULTS-INFORMED FUNDING

1 METRIC SPECIFIED IN SUBSECTION (1.3)(b) OF THIS SECTION IS BASED ON  
2 THE RATE OF CHANGE OVER TIME IN THE PERFORMANCE OF THE  
3 INSTITUTIONS OVERSEEN BY THE GOVERNING BOARD ON THE  
4 RESULTS-INFORMED FUNDING METRIC.

5 (b) THE RATE OF CHANGE FOR EACH RESULTS-INFORMED FUNDING  
6 METRIC IS CALCULATED ANNUALLY FOR A GOVERNING BOARD BY DIVIDING  
7 THE AVERAGE OF THE FOUR MOST RECENT YEARS OF ACTUAL DATA  
8 REPORTED BY THE GOVERNING BOARD FOR THE RESULTS-INFORMED  
9 FUNDING METRIC BY THE AVERAGE OF THE THREE OLDEST OF THE FOUR  
10 YEARS OF ACTUAL DATA REPORTED BY THE GOVERNING BOARD FOR THE

12 (c) THE RATE OF CHANGE FOR THE RESULTS-INFORMED FUNDING  
13 METRIC IS THEN MULTIPLIED BY EACH GOVERNING BOARD'S PREVIOUS  
14 SHARE, RESULTING IN THE GOVERNING BOARD'S PREVIOUS ADJUSTED  
15 SHARE FOR THE RESULTS-INFORMED FUNDING METRIC. THE TOTAL OF THE  
16 PREVIOUS ADJUSTED SHARES FOR ALL GOVERNING BOARDS IS THE TOTAL  
17 PREVIOUS ADJUSTED SHARE FOR THE RESULTS-INFORMED FUNDING  
18 METRIC.

19 (d) EACH GOVERNING BOARD'S ALLOCATION FOR THE  
20 RESULTS-INFORMED FUNDING METRIC IS DETERMINED BY DIVIDING THE  
21 GOVERNING BOARD'S PREVIOUS ADJUSTED SHARE FOR THE  
22 RESULTS-INFORMED FUNDING METRIC BY THE TOTAL PREVIOUS ADJUSTED  
23 SHARE FOR THE RESULTS-INFORMED FUNDING METRIC, ENSURING THAT

4 additional amount of funding pursuant to this subsection (2) for an  
5 institution, which amount is ongoing ~~base~~ PERFORMANCE funding for the

9 (a) The amount of performance funding that a governing board  
10 receives for each performance funding metric specified in subsection  
11 (4)(b) of this section is based on the rate of change over time in the  
12 performance of the institutions overseen by the governing board on the  
13 performance funding metric. The rate of change for each performance  
14 funding metric is calculated annually for a governing board by dividing  
15 the average of the four most recent years of actual data reported by the  
16 governing board for the metric by the average of the three oldest of the  
17 four years of actual data reported by the governing board for the metric.  
18 The rate of change for the performance funding metric is then multiplied  
19 by each governing board's role and mission share, resulting in the  
20 "governing board role and mission adjusted share" for the performance  
21 funding metric. The total of the governing board role and mission  
22 adjusted shares for all governing boards is the "total role and mission  
23 adjusted share" for the performance funding metric. Each governing  
24 board's allocation for the performance funding metric is then determined  
25 by dividing the governing board's role and mission adjusted share for the  
26 performance funding metric by the total role and mission adjusted share  
27 for the performance funding metric, ensuring that the total amount of

5 (7) When requesting or determining a change in performance

9 cost increases to base funding at all institutions, including those related
