**HOUSE JOINT RESOLUTION 26-1031**

101      **CONCERNING THE DESIGNATION OF THE CONVENING DATE FOR THE**  
102            **FIRST REGULAR SESSION OF THE SEVENTY-SIXTH GENERAL**  
103            **ASSEMBLY AND THE ADDITION OF A JOINT RULE ESTABLISHING**  
104            **DEADLINES THAT APPLY TO THE SENATE AND HOUSE OF**  
105            **REPRESENTATIVES FOR THE SESSION BASED ON THE CONVENING**  
106            **DATE.**

1            WHEREAS, Section 2-2-303.5 (3), Colorado Revised Statutes,  
2            authorizes the General Assembly to designate the convening date for  
3            regular sessions by joint resolution; now, therefore,

4            *Be It Resolved by the House of Representatives of the Seventy-fifth*  
5            *General Assembly of the State of Colorado, the Senate concurring herein:*

1 That, pursuant to section 2-2-303.5 (3), Colorado Revised Statutes,  
2 the General Assembly designates Monday, January 11, 2027, as the  
3 convening date for the First Regular Session of the Seventy-sixth General  
4 Assembly.

5 *Be It Further Resolved*, That in the Joint Rules of the Senate and  
6 House of Representatives, **add** Joint Rule No. 22B as follows:

7 **22B. Alternative Deadline Schedule**

8 (a) **Applicability.** THIS JOINT RULE 22B APPLIES TO THE FIRST  
9 REGULAR SESSION OF THE SEVENTY-SIXTH GENERAL ASSEMBLY,  
10 INCLUDING ANY DEADLINES RELATED TO THE SESSION THAT ARE  
11 PRIOR TO ITS CONVENING DATE. JOINT RULES 23 AND 24 CONTINUE  
12 TO APPLY DURING THE SESSION; EXCEPT THAT THIS JOINT RULE 22B  
13 SUPERSEDES CONFLICTING PROVISIONS IN JOINT RULE 23 (a)(1)  
14 AND (a)(2) AND JOINT RULE 24 (b)(1)(A) AND (c). TO THE EXTENT  
15 THAT A JOINT RULE REFERS TO THE DEADLINES ESTABLISHED IN  
16 JOINT RULE 23 (a)(1), THE REFERENCE INSTEAD APPLIES TO THE  
17 DEADLINES SET FORTH IN SUBSECTION (b)(1) OF THIS JOINT RULE  
18 22B.

15 TO EACH OF THE BILL'S SPONSORS. AT THE DISCRETION OF THE RESPECTIVE  
16 MAJORITY LEADERS, THE LIST MAY INCLUDE ANY BILLS THAT HAVE BEEN  
17 REFERRED OUT OF THE APPROPRIATIONS COMMITTEE DURING THE SEVEN  
18 LEGISLATIVE DAYS PRECEDING THE ASTERISKED FINAL PASSAGE DEADLINE.

9 (c) (1) **Bill requests.** OF THE BILLS THAT ARE SUBJECT TO THE  
10 FIVE-BILL LIMIT UNDER JOINT RULE 24 (b)(1)(A), NOT MORE  
11 THAN TWO BILLS MAY BE REQUESTED AFTER DECEMBER 1,  
12 2026; EXCEPT THAT ANY MEMBER WHO WILL SERVE IN THE  
13 FIRST REGULAR SESSION OF THE SEVENTY-SIXTH GENERAL  
14 ASSEMBLY BUT WHO IS NOT A MEMBER OF THE CURRENT  
15 GENERAL ASSEMBLY MAY NOT INTRODUCE MORE THAN  
16 TWO BILLS REQUESTED AFTER DECEMBER 15, 2026. BILLS  
17 REQUESTED ON OR BEFORE DECEMBER 1, 2026, OR  
18 DECEMBER 15, 2026, AS THE CASE MAY BE, ARE TREATED  
19 AS IF REQUESTED TO BE PREFILED BILLS, UNLESS THE  
20 MEMBER MAKING THE REQUEST SPECIFIES OTHERWISE.

21 (2) ANY MEMBER OF THE GENERAL ASSEMBLY WHO SUBMITS  
22 A BILL DRAFT REQUEST TO THE OFFICE OF LEGISLATIVE  
23 LEGAL SERVICES BY SUBJECT ONLY SHALL PROVIDE THE  
24 NECESSARY INFORMATION TO ENABLE THE OFFICE TO  
25 PROCEED WITH THE DRAFTING OF THE BILL AS SOON AS  
26 POSSIBLE. ON AND AFTER DECEMBER 1, 2026, OR  
27 DECEMBER 15, 2026, WHICHEVER IS APPLICABLE, A MEMBER  
28 MAY NOT HAVE MORE THAN FIVE DRAFT REQUESTS FOR  
29 BILLS THAT ARE NOT SUBJECT TO APPROVAL UNDER JOINT  
30 RULE 24 (b)(1)(D) ON FILE WITH THE OFFICE OF  
31 LEGISLATIVE LEGAL SERVICES AT ANY TIME.

32 (d) **Repeal.** THIS JOINT RULE 22B IS REPEALED, EFFECTIVE JANUARY  
33 1, 2028.

34 That in the Joint Rules of the Senate and House of  
35 Representatives, **amend** Joint Rule No. 23 (a)(1) as follows:

36 **23. Deadline Schedule**

1 (a) (1) **Deadline schedule.** For the purposes of organizing the  
2 legislative session, the schedule for the enactment of  
3 legislation shall be as follows:

4 5 days Deadline for filing one of each member's three bills  
5 prior to 1<sup>st</sup> requested prior to December 1 or December 15 pursuant  
6 day to paragraph (2) of this subsection (a) and Joint Rule 24  
7 (b)(1)(A) with the house of introduction for printing,  
8 distribution to Legislative Council staff for preparation of  
9 fiscal notes, and introduction on the 1st day.

10 1<sup>st</sup> day Deadline for the introduction of the bills required to be  
11 filed 5 days prior to the 1st day.

12 Deadline for introduction of any bills to increase the  
13 number of judges.

14 7<sup>th</sup> day Deadline for all remaining bill draft requests to the Office  
15 of Legislative Legal Services.

16 10<sup>th</sup> day Deadline for introduction of the two remaining Senate  
17 bills requested prior to December 1 or December 15  
18 pursuant to paragraph (2) of this subsection (a) and Joint  
19 Rule 24 (b)(1)(A).

20 17<sup>th</sup> day Deadline for introduction of the two remaining House bills  
21 requested prior to December 1 or December 15 pursuant  
22 to paragraph (2) of this subsection (a) and Joint Rule 24  
23 ~~(b)(1)(A)~~ (b)(1)(A).

24 24<sup>th</sup> day Final deadline for introduction of Senate bills, except for  
25 supplemental appropriation bills recommended by the  
26 Joint Budget Committee and the long appropriation bill.

27 27<sup>th</sup> day Deadline for introduction of supplemental appropriation  
28 bills recommended by the Joint Budget Committee.

29 31<sup>st</sup> day Final deadline for introduction of House bills, except for  
30 supplemental appropriation bills recommended by the

1 Committee or passing bills in the Legislative Council. The majority leader  
2 in each house shall direct that a memo be prepared on the date of the  
3 asterisked final passage deadline that lists all of the bills to which this  
4 exclusion applies. A copy of the memo shall be attached to each bill listed  
5 in the memo and a copy shall be sent to each of the bill's sponsors. At the  
6 discretion of the respective majority leaders, the list may include any bills  
7 that have been referred out of the Appropriations Committee during the  
8 seven legislative days preceding the asterisked final passage deadline. In  
9 addition, bills in the Appropriations Committee in either house on the day  
10 of a separate final passage deadline as specified by the Committee on  
11 Delayed Bills for that house are also excluded from the specified final  
12 passage deadline unless otherwise indicated in the delayed bill form.
