**A BILL FOR AN ACT**

101     **CONCERNING AUTOMATIC WAIVERS OF LAW FOR RURAL SCHOOL**

**Bill Summary**

The bill directs the state board of education (state board) to identify by rule a list of statutes and rules for which a rural school district board of education (local board) may invoke an automatic waiver. A local board may invoke an automatic waiver by adopting a resolution and transmitting the resolution to the state board and the commissioner of education. The local board may invoke the automatic waiver on behalf of

the entire rural school district or for one or more identified schools of the district. An automatic waiver remains in effect until revoked by the local board through adoption of a resolution. A rural school district that invokes an automatic waiver must identify the automatic waiver on its website and, starting July 1, 2020, provide a standardized description of and rationale for each automatic waiver of statute and the contact information for a school district employee who can explain the automatic waiver. The department of education, working with a statewide association that represents school districts, must adopt standardized descriptions of and rationales for each of the statutes included on the list of automatic waivers for rural school districts adopted by the state board.

1       *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 22-2-117, **amend**  
3        (3)(a) introductory portion; and **add** (7) as follows:

4           **22-2-117. Additional power - state board - waiver of**  
5       **requirements - automatic waivers - rules - definition.** (3) (a) **Any**  
6       **EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (7)(d) OF THIS SECTION,**  
7       **A waiver made pursuant to the provisions of this section shall continue**  
8       **until such time as:**

9           (7) (a) **THE STATE BOARD SHALL PROMULGATE RULES THAT LIST**  
10       **THE STATUTES AND RULES FOR WHICH A RURAL SCHOOL DISTRICT MAY**  
11       **INVOKE AN AUTOMATIC WAIVER AS PROVIDED IN THIS SUBSECTION (7). IN**  
12       **IDENTIFYING THE AUTOMATIC WAIVERS FOR RURAL SCHOOL DISTRICTS,**  
13       **THE STATE BOARD SHALL CONSIDER THE OVERALL IMPACT AND**  
14       **COMPLEXITY OF THE REQUIREMENTS SPECIFIED IN THE STATUTE OR RULE**  
15       **AND THE POTENTIAL CONSEQUENCES THAT WAIVING THE STATUTE OR**  
16       **RULE MAY HAVE ON THE PRACTICES OF A RURAL SCHOOL DISTRICT OR**  
17       **INDIVIDUAL SCHOOL. THE STATE BOARD SHALL ALSO TAKE INTO**  
18       **CONSIDERATION THE STATUTES AND RULES FOR WHICH RURAL SCHOOL**  
19       **DISTRICTS MOST OFTEN REQUEST WAIVERS PURSUANT TO SUBSECTIONS (1)**

1 AND (2) OF THIS SECTION. THE STATE BOARD MAY REVIEW AND REVISE THE  
2 LIST OF AUTOMATIC WAIVERS FOR RURAL SCHOOL DISTRICTS  
3 PERIODICALLY. NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION  
4 (7)(a) TO THE CONTRARY, THE STATE BOARD SHALL NOT INCLUDE THE  
5 FOLLOWING STATUTES ON THE LIST OF AUTOMATIC WAIVERS FOR RURAL  
6 SCHOOL DISTRICTS:

7 (I) SECTION 22-9-106, CONCERNING THE PERFORMANCE  
8 EVALUATION SYSTEM FOR LICENSED PERSONNEL;

9 (II) SECTION 22-32-109 (1)(b), CONCERNING PROCEDURES FOR  
10 COMPETITIVE BIDDING IN THE PURCHASE OF GOODS AND SERVICES, EXCEPT  
11 PROFESSIONAL SERVICES;

12 (III) SECTION 22-32-109 (1)(n), CONCERNING THE ANNUAL  
13 SCHOOL CALENDAR AND TEACHER-PUPIL CONTACT HOURS;

14 (IV) SECTION 22-32-110 (1)(y), CONCERNING THE POWER TO  
15 ACCEPT AND EXPEND GIFTS, DONATIONS, OR GRANTS;

16 (V) PART 2 OF ARTICLE 63 OF THIS TITLE 22, CONCERNING THE  
17 EMPLOYMENT OF LICENSED PERSONNEL; AND

18 (VI) A REQUIREMENT SPECIFIED IN A STATUTE LISTED IN  
19 SUBSECTION (1)(b) OR (1.5) OF THIS SECTION.

20 (b) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (1), (2),  
21 (5), OR (6) OF THIS SECTION, THE RURAL SCHOOL DISTRICT BOARD OF  
22 EDUCATION, FOR THE ENTIRE RURAL SCHOOL DISTRICT OR ON BEHALF OF  
23 ONE OR MORE SCHOOLS OF THE RURAL SCHOOL DISTRICT, MAY INVOKE THE  
24 AUTOMATIC WAIVER OF A STATUTE OR RULE SPECIFIED BY THE STATE  
25 BOARD PURSUANT TO SUBSECTION (7)(a) OF THIS SECTION BY ADOPTING  
26 A RESOLUTION, AT A REGULAR OR SPECIALLY HELD PUBLIC MEETING, THAT  
27 EXPLAINS WHY THE BOARD OF EDUCATION IS INVOKING THE WAIVER AND

1 WHETHER THE WAIVER APPLIES TO THE ENTIRE RURAL SCHOOL DISTRICT  
2 OR TO SELECTED SCHOOLS OF THE RURAL SCHOOL DISTRICT IDENTIFIED IN  
3 THE RESOLUTION. THE BOARD OF EDUCATION SHALL TRANSMIT THE  
4 ADOPTED RESOLUTION TO THE STATE BOARD AND THE COMMISSIONER.

5 (c) THE PROVISIONS OF SUBSECTION (1)(c) OF THIS SECTION  
6 CONCERNING A REQUEST FOR A WAIVER BY A PRINCIPAL OF A SCHOOL OF  
7 A SCHOOL DISTRICT THAT IS NOT A CHARTER SCHOOL APPLY TO A REQUEST  
8 BY A PRINCIPAL FOR AN AUTOMATIC WAIVER PURSUANT TO THIS  
9 SUBSECTION (7).

10 (d) AN AUTOMATIC WAIVER INVOKED BY A RURAL SCHOOL  
11 DISTRICT BOARD OF EDUCATION PURSUANT TO THIS SUBSECTION (7)  
12 CONTINUES IN EFFECT UNTIL REVOKED BY A RESOLUTION ADOPTED BY THE  
13 DISTRICT BOARD OF EDUCATION AND TRANSMITTED TO THE STATE BOARD  
14 AND THE COMMISSIONER.

15 (e) THE PROVISIONS OF THIS SUBSECTION (7) DO NOT AUTHORIZE  
16 A RURAL SCHOOL DISTRICT BOARD OF EDUCATION TO INVOKE AN  
17 AUTOMATIC WAIVER ON BEHALF OF, OR APPLY AN AUTOMATIC WAIVER TO,  
18 A CHARTER SCHOOL OF THE RURAL SCHOOL DISTRICT. A CHARTER SCHOOL  
19 OF A RURAL SCHOOL DISTRICT IS SUBJECT TO THE AUTOMATIC WAIVER  
20 PROVISIONS SPECIFIED IN SECTIONS 22-30.5-104 (6) AND 22-30.5-105 (3).

21 (f) AS USED IN THIS SUBSECTION (7), "RURAL SCHOOL DISTRICT"  
22 MEANS A SCHOOL DISTRICT IN COLORADO THAT THE DEPARTMENT  
23 DETERMINES IS RURAL, BASED ON THE GEOGRAPHIC SIZE OF THE SCHOOL  
24 DISTRICT AND THE DISTANCE OF THE SCHOOL DISTRICT FROM THE NEAREST  
25 LARGE, URBANIZED AREA.

26 **SECTION 2.** In Colorado Revised Statutes, 22-44-305, **amend**  
27 (1)(b) and (1)(c); and **add** (2.5) as follows:

1                   **22-44-305.      Waivers of state statute - reporting.**

2       (1) (b) Commencing July 1, 2018, ~~each~~ FOR CHARTER SCHOOLS AND  
3       COMMENCING JULY 1, 2020, FOR RURAL SCHOOL DISTRICTS, AS DEFINED  
4       IN SECTION 22-2-117(7), EACH RURAL SCHOOL DISTRICT AND EACH charter  
5       school shall post, in a location and format that can be easily accessed and  
6       downloaded, for free public access on its website the standardized  
7       description and rationale created pursuant to subsection (2) of this section  
8       for each of the automatic waivers that it invokes. Each RURAL SCHOOL  
9       DISTRICT AND EACH charter school shall post with the list of automatic  
10       waivers the name of and contact information for a person employed by  
11       the RURAL SCHOOL DISTRICT OR charter school and available during  
12       regular school hours who can provide additional information concerning  
13       the RURAL SCHOOL DISTRICT'S OR charter school's automatic waivers.

14                   (c) In listing its waivers, a school district, INCLUDING A RURAL  
15       SCHOOL DISTRICT, shall include AUTOMATIC WAIVERS, IF APPLICABLE,  
16       INVOKED BY AND waivers granted to the school district as a whole and  
17       AUTOMATIC WAIVERS, IF APPLICABLE, INVOKED FOR AND waivers granted  
18       to one or more schools of the school district, other than a charter school.  
19       The school district shall list separately each AUTOMATIC WAIVER, IF  
20       APPLICABLE, INVOKED FOR AND waiver granted to an innovation school or  
21       to schools in an innovation school zone, as defined in section  
22       22-32.5-103.

23                   (2.5) BY JULY 1, 2020, THE DEPARTMENT, WORKING WITH A  
24       STATEWIDE ASSOCIATION THAT REPRESENTS SCHOOL DISTRICTS, SHALL  
25       DEVELOP A STANDARDIZED DESCRIPTION FOR EACH STATUTE THAT THE  
26       STATE BOARD OF EDUCATION INCLUDES IN THE LIST OF AUTOMATIC  
27       WAIVERS FOR RURAL SCHOOL DISTRICTS PURSUANT TO SECTION 22-2-117

1 (7) AND THE RATIONALE FOR INCLUDING THE STATUTE ON THE LIST OF  
2 AUTOMATIC WAIVERS.

3 **SECTION 3. Act subject to petition - effective date.** This act  
4 takes effect at 12:01 a.m. on the day following the expiration of the  
5 ninety-day period after final adjournment of the general assembly (August  
6 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a  
7 referendum petition is filed pursuant to section 1 (3) of article V of the  
8 state constitution against this act or an item, section, or part of this act  
9 within such period, then the act, item, section, or part will not take effect  
10 unless approved by the people at the general election to be held in  
11 November 2020 and, in such case, will take effect on the date of the  
12 official declaration of the vote thereon by the governor.
