**A BILL FOR AN ACT**

101     **CONCERNING ALLOWING THE ADOPTION OF A CHILD UNDER THE**  
102         **JURISDICTION OF A COURT IN COLORADO WHO IS NOT PRESENT**  
103         **IN COLORADO.**

**Bill Summary**

Under current law, for a child to be adopted, the child must be present in the state at the time that the petition for adoption is filed. Under the bill, the child need not be present in the state if the child has been under the jurisdiction of a court in Colorado for at least 6 months.

1       *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 19-5-201 as  
3 follows:

4           **19-5-201. Who may be adopted.** Any child LEGALLY AVAILABLE  
5 FOR ADOPTION AS PROVIDED IN SECTION 19-5-203, under eighteen years  
6 of age, AND EITHER present in the state at the time the petition for  
7 adoption is filed ~~and legally available for adoption as provided in section~~  
8 ~~19-5-203~~ OR UNDER THE JURISDICTION OF A COURT IN COLORADO FOR AT  
9 LEAST SIX MONTHS may be adopted. Upon approval of the court, a person  
10 eighteen years of age or older and under twenty-one years of age may be  
11 adopted as a child, and all provisions of this part 2 referring to the  
12 adoption of a child shall apply to such a person.

13           **SECTION 2. Effective date - applicability.** This act takes effect  
14 July 1, 2017, and applies to petitions filed on or after said date.

15           **SECTION 3. Safety clause.** The general assembly hereby finds,  
16 determines, and declares that this act is necessary for the immediate  
17 preservation of the public peace, health, and safety.
