HB26-1107 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 3, strike lines 2 through 19.
- 2 Page 4, strike lines 1 through 15.
- 3 Renumber succeeding sections accordingly.
- 4 Page 4, line 19, strike "**deceptive trade practice -**" and substitute "**gifts,**
5 **grants, or donations -**".
- 6 Page 4, strike lines 24 through 26 and substitute "AND THAT OFFERS
7 ON-SITE AND RESIDENTIAL SERVICES FOR INDIVIDUALS WITH DEMENTIA
8 DISEASES AND RELATED DISABILITIES."
- 9 Page 5, line 9, strike "JANUARY" and substitute "JULY".
- 10 Page 6, line 2, strike "MEMBERS, ESPECIALLY FAMILY CAREGIVERS," and
11 substitute "MEMBERS".
- 12 Page 6, line 18, after "AFFAIRS;" add "AND".
- 13 Page 6, line 19, strike "SCHEDULE," and substitute "MODEL,".
- 14 Page 6, lines 20 and 21, strike "INCLUDING THE FEES CHARGED TO
15 RESIDENTS AND WHAT SERVICES ARE AND ARE NOT COVERED BY THE
16 FEES."
- 17 Page 6, strike lines 25 and 26.

1 Page 7, after line 11 insert:

2 "(e) THE DEPARTMENT MAY SEEK, ACCEPT, AND EXPEND GIFTS,
3 GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES FOR THE
4 PURPOSES STATED IN THIS SUBSECTION (2) OR SUBSECTION (4) OF THIS
5 SECTION."

6 Page 7, line 18, strike "JULY" and substitute "OCTOBER".

7 Page 8, strike lines 19 through 27 and substitute:

8 "(c) IF A FACILITY VIOLATES SUBSECTION (3)(b)(V) OF THIS
9 SECTION OR DOES NOT PRODUCE THE FACILITY'S CURRENT FORM UPON A
10 REQUEST MADE BY THE DEPARTMENT PURSUANT TO SUBSECTION (4)(b) OF
11 THIS SECTION, THE DEPARTMENT SHALL ISSUE A CITATION TO THE
12 FACILITY."

13 Strike pages 9 through 12.

14 Page 13, strike lines 1 through 14.

15 Renumber succeeding section accordingly.
