SB26-032 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 11 (1) THE BOARD OF HEALTH SHALL ADOPT RULES ESTABLISHING A  
12 SCHEDULE OF RECOMMENDED ADULT IMMUNIZATIONS, INCLUDING:
- 13 (a) THE VACCINES OR OTHER IMMUNIZING AGENTS RECOMMENDED  
14 FOR ADULTS, AFTER TAKING INTO CONSIDERATION THE  
15 RECOMMENDATIONS OF THE ACIP, THE AMERICAN ACADEMY OF  
16 PEDIATRICS, THE AMERICAN ACADEMY OF FAMILY PHYSICIANS, THE  
17 AMERICAN COLLEGE OF OBSTETRICIANS AND GYNECOLOGISTS, OR THE  
18 AMERICAN COLLEGE OF PHYSICIANS; AND
- 19 (b) THE MANNER AND FREQUENCY OF ADMINISTRATION.".
- 20 Page 14, line 4, strike "**25-4-2604.**" and substitute "**25-4-2605.**".
- 21 Page 14, strike lines 9 through 13 and substitute "ADMINISTERED IN  
22 ACCORDANCE WITH THE SCHEDULE OF RECOMMENDED ADULT  
23 IMMUNIZATIONS ESTABLISHED BY THE STATE BOARD OF HEALTH  
24 PURSUANT TO SECTION 25-4-2604;".
