After consideration on the merits, the Committee recommends the following:

SB26-147 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 11, strike "(1),".
- 2 Page 3, strike line 12 and substitute:
  - 3 "(3.7) and (6); and **add** (3.8) and (3.9) as follows:".
- 4 Page 3, strike lines 15 through 27.
- 5 Page 4, strike lines 1 through 15.
- 6 Page 4, lines 16 and 17, strike "AN ADVOCACY DAY PARTICIPANT,".
- 7 Page 5, lines 6 and 7, strike "AN ADVOCACY DAY PARTICIPANT,".
- 8 Page 6, lines 23 and 24, strike "OR AN ADVOCACY DAY PARTICIPANT".
- 9 Page 7, strike lines 9 through 27.
- 10 Page 8, strike lines 1 through 21.
- 11 Renumber succeeding sections accordingly.
- 12 Page 8, line 24, after "(2)(a)(IV)" insert "and (6)".
- 13 Page 10, strike lines 19 through 26 and substitute:
  - 14 "(IV) THE BILL OR RESOLUTION NUMBER OF THE LEGISLATION AT
  - 15 ISSUE AND THE LEGISLATIVE POSITION OF THE PERSON ON WHOSE BEHALF

1 THE INDIVIDUAL IS LOBBYING. THE POSITION MUST BE INDICATED ON THE  
2 INDIVIDUAL'S DISCLOSURE STATEMENT AND MUST INCLUDE WHETHER THE  
3 PERSON IS SUPPORTING, OPPOSING, AMENDING, OR MONITORING THE  
4 LEGISLATION. IF THE PERSON'S POSITION CHANGES, THE INDIVIDUAL SHALL  
5 UPDATE THE POSITION INDICATED ON THE DISCLOSURE STATEMENT WITHIN  
6 SEVENTY-TWO HOURS OF THE CHANGE."

7 Page 11, after line 14 insert:

9 "(6) NO STATEWIDE ELECTED OFFICEHOLDER OR MEMBER OF THE  
10 GENERAL ASSEMBLY IS ALLOWED TO BE THE PERSON DESIGNATED TO  
11 LOBBY PURSUANT TO SECTION (1)(a) OF THIS SECTION FOR A PERIOD OF  
12 TWO YEARS FOLLOWING VACATION OF OFFICE."
