HB26-1335 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 3, after line 24 insert:
 - 2 "(d) "OTHER OUTLET" HAS THE MEANING SET FORTH IN SECTION
 - 3 12-280-103.
 - 4 (e) "PRESCRIPTION DRUG OUTLET" HAS THE MEANING SET FORTH
 - 5 IN SECTION 12-280-103."
- 6 Reletter succeeding paragraph accordingly.
- 7 Page 3, line 27, strike "HEALTH-CARE SERVICES" and substitute "PRIMARY
- 8 CARE SERVICES OR REPRODUCTIVE HEALTH-CARE SERVICES".
- 9 Page 4, lines 20 and 21, strike "A PHARMACY LOCATED OFF CAMPUS" and
- 10 substitute "AN OFF-SITE PRESCRIPTION DRUG OUTLET OR OTHER OUTLET".
- 11 Page 4, line 21, strike "INSTITUTION." and substitute "INSTITUTION OR
- 12 OTHERWISE SEEK ABORTION CARE FROM A HEALTH-CARE PROVIDER THAT
- 13 IS UNAFFILIATED WITH THE INSTITUTION."
- 14 Page 5, line 8, strike "LAW," and substitute "LAW OR VALID COURT ORDER
- 15 ISSUED BY A COURT OF THIS STATE,".
- 16 Page 5, line 14, after "ACTIVITY." add "AN INSTITUTION SHALL MAINTAIN
- 17 PERSONALLY IDENTIFIABLE INFORMATION IN COMPLIANCE WITH THE LAWS
- 18 OF THIS STATE, INCLUDING LIMITATIONS ON INFORMATION DISCLOSURE
- 19 PURSUANT TO SECTION 24-116-102."
- 20 Page 5, line 25, strike "OR".

1 Page 6, line 1, strike "BONA FIDE" and substitute "SINCERELY HELD".

2 Page 6, line 2, strike "PRACTICES." and substitute:

3 "PRACTICES;

4 (d) REQUIRE A HEALTH-CARE PROVIDER, INSTITUTION, OR STUDENT
5 HEALTH CENTER TO PROVIDE ACCESS TO OR STOCK ABORTION MEDICATION
6 IF DOING SO WOULD VIOLATE FEDERAL LAW OR REGULATIONS OR WOULD
7 JEOPARDIZE AN INSTITUTION'S FEDERAL GRANT PARTICIPATION;

8 (e) REQUIRE AN INSTITUTION OR A STUDENT HEALTH CENTER TO
9 DEVIATE FROM GENERALLY ACCEPTED BILLING PRACTICES; OR

10 (f) MODIFY THE GENERALLY ACCEPTED STANDARDS OF MEDICAL
11 PRACTICE IN THIS STATE OR PROHIBIT A HEALTH-CARE PROVIDER FROM
12 MAKING A REFERRAL TO ANOTHER HEALTH-CARE PROVIDER OR
13 HEALTH-CARE FACILITY WHEN, IN THE HEALTH-CARE PROVIDER'S CLINICAL
14 JUDGEMENT, A STUDENT'S INDIVIDUAL CIRCUMSTANCES REQUIRE THE
15 REFERRAL."
