Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB26-114 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Business, Labor, and Technology Committee Report, dated  
2 April 2, 2026, page 1, line 7, strike "MANUFACTURER'S".
  
- 3 Page 1, line 8, strike "AT UP TO TWO APPROVED SALES ROOMS." and  
4 substitute "ANY SALES ROOM APPROVED PURSUANT TO SUBSECTION  
5 (7)(a)(I)(A) OF THIS SECTION. EXCEPT AS OTHERWISE PROVIDED IN  
6 SUBSECTION (7)(a)(II) OF THIS SECTION, THE MANUFACTURER SHALL ONLY  
7 SERVE OR SELL ALCOHOL BEVERAGES ACQUIRED FROM SUCH  
8 WHOLESALERS FOR ON-PREMISES CONSUMPTION AND NOT FOR  
9 OFF-PREMISES CONSUMPTION OR FOR TAKEOUT AND DELIVERY PURSUANT  
10 TO SECTION 44-3-911 (4)(c)(V).".
  
- 11 Page 1, strike lines 12 and 13 and substitute "AUTHORITY SHALL ONLY  
12 EVALUATE".
  
- 13 Page 1, line 15, strike "SECTION" and substitute "SUBSECTION  
14 (7)(a)(I)(B)".
  
- 15 Page 1, line 17, after the period add "THE STATE LICENSING AUTHORITY  
16 SHALL DETERMINE THE FORM AND MANNER OF A PERMIT APPLICATION  
17 SUBMITTED PURSUANT TO THIS SUBSECTION (7)(a)(I)(B).".
  
- 18 Page 1, line 18, after "OF" insert "A PERMIT FROM" and strike  
19 "AUTHORITY," and substitute "AUTHORITY PURSUANT TO SUBSECTION  
20 (7)(a)(I)(B) OF THIS SECTION,".
  
- 21 Page 1, line 19, strike "SPIRITOUS" and substitute "SPIRITUOUS".

- 1 Page 2, line 4, strike "after line 16" and substitute "before line 17".
- 2 Amend printed bill, page 2, line 3, strike "(7)(a)" and substitute "(7)(a);  
3 and **add** (7)(d)".
- 4 Page 2, line 8, strike "~~one~~ UP TO TWO" and substitute "one".
- 5 Page 2, line 9, strike "~~location~~ LOCATIONS" and substitute "location".
- 6 Page 3, line 1, strike "~~only one~~ UP TO TWO" and substitute "only one".
- 7 Page 3, strike lines 3 and 4 and substitute "PURSUANT TO THIS SECTION  
8 SHALL APPLY TO THE STATE LICENSING AUTHORITY FOR A".
- 9 Page 3, strike lines 7 and 8 and substitute "AT THE LICENSED PREMISES  
10 AND ANY SALES ROOM APPROVED PURSUANT TO SUBSECTION (7)(a)(I)(A)  
11 OF THIS SECTION. EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION  
12 (7)(a)(II) OF THIS SECTION, THE MANUFACTURER SHALL ONLY SERVE OR  
13 SELL ALCOHOL BEVERAGES ACQUIRED FROM SUCH WHOLESALERS FOR  
14 ON-PREMISES CONSUMPTION AND NOT FOR OFF-PREMISES CONSUMPTION  
15 OR FOR TAKEOUT AND DELIVERY PURSUANT TO SECTION 44-3-911  
16 (4)(c)(V). THE STATE LICENSING AUTHORITY SHALL".
- 17 Page 3, line 14, strike "ON THE SALES ROOM PREMISES," and substitute "AT  
18 ITS LICENSED PREMISES AND ANY APPROVED SALES ROOM,".
- 19 Page 3, line 16, after "FROM" insert "SUCH".
- 20 Page 3, line 18, after the period add "A PERMIT ISSUED UNDER THIS  
21 SUBSECTION (7)(a)(I)(C) IS VALID UNTIL THE EXPIRATION OF THE PERMIT  
22 ISSUED BY THE LOCAL LICENSING AUTHORITY PURSUANT TO SUBSECTION  
23 (7)(a)(I)(B) OF THIS SECTION OR FOR ONE YEAR AFTER THE DATE OF  
24 ISSUANCE, WHICHEVER IS SOONER, UNLESS THE PERMIT IS REVOKED OR  
25 SUSPENDED PURSUANT TO SECTION 44-3-306 OR 44-3-601.".
- 26 Page 5, after line 16 insert:
- 27 "(d) THE STATE LICENSING AUTHORITY MAY ADOPT RULES TO  
28 IMPLEMENT THIS SUBSECTION (7).".
